

4 CONTROLLING PARTY AND RELATED PARTY TRANSACTION

The company is controlled by and its funding is derived solely from its parent company, V I Technologies Inc (the 'Parent Company'), a research and development company based in the United States of America. The Parent Company has lent money to the company on an interest free basis. There is no due date on this loan and the Parent Company does not expect payment on this loan within one year. The amount outstanding on this loan at the year end was £8,965 (2005 - £9,502). The Parent Company has the intent and capability of sponsoring and funding the operations of VI Technologies Limited. The director of the company is also the chief executive officer of the Parent Company.
