1 Statutory information

Regal (West Point) Limited is a private company, limited by shares, registered in England and Wales, registration number 4105394. The registered office is Forward House, 17 High Street, Henley in Arden, Warwickshire, B95 5AA, United Kingdom.

2 Compliance with accounting standards

The accounts have been prepared in accordance with the provisions of FRS 102 Section 1A Small Entities. There were no material departures from that standard.

3 Accounting policies

These financial statements for the year ended 31 March 2019 are the first financial statements that comply with FRS 102 Section 1A Small Entities. The date of transition is 1 April 2017.
