

1 ACCOUNTING POLICIES

(a) **Accounting Convention**

The financial statements have been prepared under the Historical Cost convention.

(b) **Turnover**

Turnover represents invoices raised and sales receipts during the period,

(c) **Depreciation of Tangible Fixed Assets**

Depreciation is provided to write off the cost of fixed assets on a straight line basis over their estimated useful lives.

A full years depreciation is provided on fixed assets in the period of acquisition, no depreciation is provided in the period of disposal.

(d) **Stock**

Stock is valued by the Directors at the lower of cost and net realisable value.

(e) **Exemption from the Preparation of a Cashflow Statement**

A cashflow statement in accordance with the requirements of Financial Reporting Standard 1, has not been prepared on the grounds that the company qualifies as a small company and is therefore exempt from the requirement.
