

- 3) Further to clause 11 of the Deed, the Chargor shall, at its own expense, take whatever action the Security Trustee or a receiver may reasonably require for.-
- (a) perfecting or protecting the security intended to be created by the Deed over any part of the Charged Assets;
- (b) facilitating the realisation of the whole or any part of the Charged Assets or the exercise of any right, power or discretion exercisable, by the Security Trustee or any Receiver or any of its or their delegates or sub-delegates in respect of the whole or any part of the Charged Assets

including the execution of any transfer, conveyance, assignment or assurance of any property whether to the Security Trustee or to its nominees, and the giving of any notice, order, or direction and the making of any registration, which in any case, the Security Trustee may think expedient provided that such action will not create obligations on the Chargor which are more onerous than those existing under the terms of the Deed (unless required by law).

POWER OR ATTORNEY

4) Pursuant to clause 12 of the Deed, following the occurrence of an Event of Default which is continuing, the Chargor, by way of security, irrevocably appoints the Security Trustee, each Receiver and any of their delegates or sub-delegates to be its attorney to take any action which the Chargor is obliged to take under the Deed. The Chargor ratifies and confirms that whetever attorney does or purports to do pursuant to its appointment under clause 12 of the Deed.
