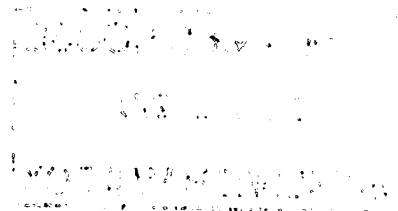

1. General information

ESS Steels Group Limited is a limited company registered in England and Wales. The company's registered office and principal place of business is Cortonwood Drive, Dearne Valley, South Yorkshire, S73 0UF.

2.1 Basis of preparation of financial statements
