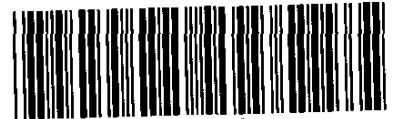





- 2 that the Company will be able to pay (or otherwise discharge) its debts as they fall due during the year immediately following the commencement of the winding up.


