#### **Our Aims and Objectives**

#### **Purposes and Aims**

The Charity's purposes as set out in the objectives contained in the company's memorandum of association, and further developed in the current Business Plan, are:

- To become a young person led and centred organisation.
- To support young people to emotionally and practically empower themselves through the provision of free counselling, information, participation, and development work.
- To promote the positive mental health and well-being of all young people.
- To promote young people's rights and participation in relation to mental health and well-being in all areas of public life.

### **Delivering public benefit**

All OTR's charitable activities focus on the provision of accessible and effective mental health support and campaigning for young people 11-25 resident in Bristol and the surrounding area. Such a programme of activity is invariably of public benefit insofar as it contributes to healthy, active citizens, family and community cohesion, and increased social inclusion and mobility. Public benefit is also derived from the prevention of escalating levels of mental ill-health among OTR's service users as a consequence of their accessing the organisation. That OTR offers a free and timely service for vulnerable young people is of public benefit in terms of cost-effectiveness in both the short and long term.

#### History, achievements, performance and future plans of the Charity

Off the Record (Bristol) was founded in 1965 and can justifiably claim to be one of the oldest youth counselling agencies in the country. The service began life as a result of a combined initiative between the Bristol Association of Youth Clubs and the Bristol Marriage and Family Guidance Council, who saw in their work a great unmet need for a free and confidential youth counselling service.

2013-14 was another busy year, as OTR moved into the first year of a new Business Plan (2013-16) and continued to grow services in a number of new and expanded directions. Our established counselling services continued to experience unprecedented demand (both in numbers and complexity) even despite the addition of Friday and Saturday opening, an art therapy service, and eight outreach services across the city. Our team of Youth Support Workers worked hard embedding a new model of psychologically informed youth work to help manage this demand, which totalled just under 3,000 calls and direct ongoing support for 1200 individuals by the end of the year.

The Mentality Project finished their three-year funding granted by Comic Relief with a youth-led conference in January attended by over 150 parents, young people and professionals. Shortly afterwards we received the good news that Comic Relief were to continue to fund the project, which in this final year reached over 5000 young people through workshops, training and events in schools and other youth settings.

Our psycho-education project, The Resilience Lab entered its second year, offering bi-weekly workshops that taught over 200 different young people about self care, stress management and healthy coping strategies. We also developed targeted youth work support for Black and Minority Ethnic young women in Easton, and right at the end of the year took on the specialist youth work contract for Lesbian, Gay, Bisexual and Transgender young people within the Bristol Youth Links consortium.

Much of the year was spent strategically engaged in the largest tender OTR has been involved with in its history. The re-commissioning of adult community mental health services across the city presented an opportunity for OTR to try and secure for the first time statutory

resources for those young people aged 18-25 accessing our support. A complex and wide ranging partnership of ten third sector providers (including OTR) and Avon and Wiltshire Mental Health NHS Partnership Trust eventually won the five year contract to deliver radical new citywide mental health services in the city. For OTR, this work will compliment the expanded NHS IAPT talking therapies service which expanded as the year wore on, and will provide a strong basis from which to compete for the upcoming local CAMHS re-procurement in 2015-16.

Finally, investment in the OTR infrastructure also continued, with the ground floor at St Michaels Hill given a long overdue refurbishment to give the main service a more contemporary look and feel.

#### **Financial Review**

#### **Reserves Policy**

The Board of Trustees has examined the Charity's requirement for reserves in the light of the main risks to the organisation. It has established a policy whereby the unrestricted funds not committed or invested in tangible fixed assets held by the Charity should be between three and six months of the expenditure. The total expenditure for 2013/14 was £394,694 therefore the target is £98,674 - £197,347 in general reserves. The reserves are needed to meet the working capital requirements of the Charity and the Executive are confident that at this level they would be able to continue the current activities of the Charity in the event of a significant drop in funding. At the end of 2013/14 free cash reserves stood at £92,031, which represents just less than three months running costs.

In recognition of the importance of maintaining a healthy level of reserves the Board of Trustees have included reserve balances on the organisations risk register which is reviewed by the Board on a quarterly basis.

#### Structure, Governance and Management

The organisation is a charitable company limited by guarantee, incorporated on 1<sup>st</sup> October 2007 and registered as a charity in 1964. The company was established under a Memorandum of Association which established the objectives and powers of the charitable company and is governed under its Articles of Association. In the event of the company being wound up members are required to contribute an amount not exceeding £1.

#### **Appointment of the Board of Trustees**

The directors of the company are also charity trustees for the purposes of charity law and under the company's Articles are known as members of the Board of Trustees. Under the requirements of the Memorandum and Articles of Association there are a minimum of four and maximum of fifteen trustees. Not more than three trustees may be volunteers and a third of trustees must retire at each AGM, with the longest in office retiring first

#### **Trustee Management and Training**

All trustees are fully inducted into OTR's governance. Trustees are drawn from a variety of health, education and social care professional backgrounds and a skills analysis is kept to ensure trustees are able to contribute in full.

# Risk Assessment and Management

The Board of Trustees has reviewed the major risks to which the Charity is exposed, and have taken steps to mitigate those risks identified.

## Responsibilities of the Board of Trustees

Company law requires the Board of Trustees to prepare financial statements for each financial year, which give a true and fair view of the state of affairs of the charitable company and the surplus or deficit of the charitable company for that period. In preparing those financial statements, the Board of Trustees is required to

- · Select suitable accounting polices and apply them consistently
- · Make judgements and estimates that are reasonable and prudent
- State whether applicable accounting standards have been followed, subject to any material departures disclosed and explained in the financial statements
- Prepare the financial statements on the going concern basis unless it's inappropriate to presume that the company will continue its operations

The Board of Trustees are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the charitable company and to enable them to ensure that the financial statements comply with the Companies Act 2006. They are also responsible for safeguarding the assets of the charitable company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

# Notes forming part of the Financial Statements for the period 31<sup>st</sup> March 2014

# 1. Accounting Policies

The principal accounting policies are summarised below. The accounting policies have been applied consistently throughout the year.

#### **Basis of accounting**

The financial statements have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective January 2005), the Companies Act 2006 and follow the recommendations in Accounting and Reporting by Charities: Statement of Recommended Practice 2005 (SORP 2005).

#### **Fund Accounting**

Unrestricted funds are available for use at the discretion of the trustees in furtherance of the general objectives of the charity.

Designated funds are unrestricted funds earmarked by the Board of Trustees for particular purposes.

#### **Incoming Resources**

All incoming resources are included in the Statement of Financial Activities when the charity is legally entitled to the income and the amount can be quantified with reasonable accuracy.

#### **Resources Expended**

Expenditure is recognised on an accrual basis as a liability is incurred. Expenditure includes VAT, which is reported as part of the expenditure to which it relates.

Charitable expenditure comprises those costs directly incurred by the Charity in the delivery of its activities and services for its beneficiaries.

Governance costs includes those costs associated with meeting the constitutional and statutory requirements of the Charity and include the audit fee and costs linked to the strategic management of the Charity.

## **Fixed Assets**

Fixed assets are stated at cost or valuation.
