ORDER

UPON the application of Steven Mark Law, Abigail Shearing, Bruce Alexander Mackay and George Arthur Peter Maloney dated 5 November 2020



AND UPON reading the First Witness Statement of Steven Mark Law with Exhibit SML1 dated 28 October 2020 and a letter from Howes Percival dated 25 November 2020 enclosing an email from the Insolvency Service dated 17 November 2020 stating that there are no regulatory or resource concerns regarding the block transfer

AND WITHOUT A HEARING

IT IS ORDERED THAT:

- 1 Steven Mark Law ("**the Outgoing Officeholder**") be removed from office in respect of each of the cases listed in Schedule 1 (attached to this order) ("**Block Transfer Cases**") from the date of this order.
- 2 Abigail Shearing be appointed as joint replacement officeholder in respect of each of the Block Transfer Cases listed in Part 1 of Schedule 1.
- 3 Graham Bushby be appointed as joint replacement officeholder in respect of each of the Block Transfer Cases listed in Part 2 of Schedule 1.
- 4 Tyrone Courtman be appointed as joint replacement officeholder in respect of each of the Block Transfer Cases listed in Part 3 of Schedule 1.
- 5 Karen Ann Spears be appointed as joint replacement officeholder in respect of each of the Block Transfer Cases listed in Part 4 of Schedule 1.
- 6 The creditors in each of the Block Transfer Cases listed in Schedule 1 be notified of this order by one composite advertisement in the London Gazette within 14 days of receipt of the sealed order, and within the body of the report at the time of the next statutory reporting requirement for each case.
- 7 Any creditor, or, in the case of any members' voluntary liquidation, any member, in respect of any of the companies or persons listed in Schedule 1 who has an objection to this order shall have 28 days from the date of the advertisement in accordance with the preceding paragraph to apply to court to set aside or vary the terms of this order. Such application shall not affect the transfer of the Block Transfer Cases listed in Schedule 1 until further or other order by the court.
- 8 Following the removal of the Outgoing Officeholder from his offices as liquidator pursuant to paragraph 1 above, the Outgoing Officeholder shall have his release on the date of the order without being required to (i) apply to the Secretary of State for

release or discharge as appropriate pursuant to s173(2)(b) or s174(4)(b) of the Insolvency Act 1986 as the case may be, or (ii) file a receipts and payments account.

- 9 Where in any matter an officeholder is as a consequence of this order appointed jointly with another, any act required or authorised under any enactment to be done by joint appointees may be done by all or any one or more of the persons at the time being holding office. No functions are required to be undertaken by both joint appointees acting together and no functions are specifically the responsibility of either joint appointee.
- 10 In respect of any existing court applications or proceedings arising out of any of the matters listed in Schedule 1 of this order, the replacement officeholder shall be substituted for the Outgoing Officeholder by virtue of this order and pursuant to Rule 12.37(1)(e) of the Insolvency (England and Wales) Rules 2016.
- 11 Where the Outgoing Officeholder is removed and replaced as Administrator, in respect of the companies in Schedule 1, and those administrations are subsequently converted into Creditors' Voluntary Liquidations, the replacement Administrator in each case, as set out in the Schedule, shall also replace the Outgoing Officeholder as Liquidator.
