

INTRODUCTION

The Company was placed into members' voluntary liquidation on 20 October 2016 when Emma Cray and Karen Dukes were appointed joint liquidators (the liquidators).

We are required to provide you with a final account on the conduct and outcome of the liquidation. This account is for the period 20 October 2016 to 13 June 2017 and also serves as a progress report from 20 October 2016 to 13 June 2017.

We are also required to give you certain information about the Company and the liquidators; this information is attached as Appendix A.

We attach as Appendix B a summary of our receipts and payments for the liquidation.

REPORT ON THE LIQUIDATION

Realisation of assets:

The directors' Declaration of Solvency showed that the Company had no assets.

No additional assets have been identified and there are no assets still to be realised.

Settlement of liabilities:

This section covers all liabilities except any claims of HM Revenue & Customs (HMRC) which are dealt with separately below under HMRC.

The directors' Declaration of Solvency and the Company's records showed the Company had no liabilities.

After our appointment we published a notice in the London Gazette inviting any unknown creditors to send in their claims. No claims were received following the notice.

There are no remaining claims to be agreed or settled.

HMRC:

The directors' Declaration of Solvency and the Company's records showed that the Company had no tax liabilities.

After our appointment, we wrote to HMRC to inform them of our appointment and to request details of any outstanding liabilities.

All matters have now been cleared and HMRC have confirmed their agreement to us closing the liquidation.

Distributions to shareholders:

At the time of our appointment, the issued share capital of the Company consisted of:

- 100 Ordinary £1 shares

As there were no assets to distribute, a nil sweeper distribution comprising of any other assets was made. A notional value of £1 was attributed to the distribution to cover any assets arising in the future. The sweeper distribution provides the paperwork to transfer ownership of these back to the shareholder.

OUR FEES AND EXPENSES

Basis of remuneration:

At the time of our appointment, a resolution was passed for us to be paid by reference to the time properly given by us and our staff in dealing with the liquidation.

Funding of the liquidation:

Although fees have been paid to us on the basis specified above, our fees and expenses have not been paid out of the liquidation estate. Instead, Peopleplus Group Limited has met our fees and expenses for the Company and the 3 connected companies listed in Appendix C. (Note: One of the three companies, A4E Wales Limited, has yet to be placed into liquidation).

Remuneration charged:

Our fees for undertaking this assignment consist of time costs incurred for both (i) the period up to the day of our appointment and (ii) the period covering the formal liquidation. Our time costs for these periods were:

The above time costs for the liquidation period are calculated to 12 May 2017, being the latest practicable date. This represents 34.30 hours at an average hourly rate of £279.30.

£28,240 (excluding disbursements and VAT) has been invoiced for this case. It is our normal practice to obtain the prior approval of Peopleplus Group Limited before fees are invoiced. Final fees of £3,000 have been agreed to finalise and close the liquidations of A4E Europe Limited, A4E Management Ltd and A4E Ireland Limited.

Liquidators' expenses:

During the liquidation we have incurred expenses of £774.01 plus VAT. The following disbursements of £734.01 plus VAT have been re-charged and consist of:
