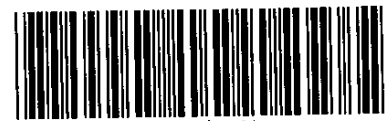

**ORDER**

---

UPON reading the Claimants' application by way of a part 8 claim form issued on 24 January 2020

AND UPON reading the witness evidence of Frances Churchard and Steven John Petch

AND UPON the Defendant having confirmed that they have no objections to an order being made in these terms

**IT IS DECLARED THAT:**

- 1 Two Form MR04s registered on 13 November 2019 which satisfied two charges created on 3 July 2014 between the Royal Bank of Scotland (as security agent for the beneficiaries) and RQIH Limited (being the First Claimant) with charge codes 0367 1097 0005 and 0367 1097 0006 were delivered in error and were ineffective.
- 2 Three Form MR04s registered on 13 November 2019 which satisfied three charges created on 3 July 2014 between the Royal Bank of Scotland (as security agent for the beneficiaries) and R&Q Central Services Limited (being the Second Claimant) with charge codes 0417 9375 0003, 0417 9375 0004 and 0417 9375 0005 were delivered in error and were ineffective.
- 3 The Form MR04 registered on 13 November 2019 which satisfied a charge created on 3 July 2014 between the Royal Bank of Scotland (as security agent for the beneficiaries) and Randall & Quilter II Holdings Limited (being the Third Claimant) with charge code 0765 9577 0004 was delivered in error and was ineffective.
- 4 The Form MR04 registered on 13 November 2019 which satisfied a charge created on 3 July 2014 between the Royal Bank of Scotland (as security agent for the beneficiaries) and Randall & Quilter IS Holdings Limited (being the Fourth Claimant) with charge code 0765 9581 0002 was delivered in error and was ineffective.
- 5 The Form MR04s registered on 13 November 2019 which satisfied a charge created on 3 July 2014 between the Royal Bank of Scotland (as security agent for the beneficiaries) and Randall & Quilter Underwriting Management Holdings Limited (being the Fifth Claimant) with charge code 0750 4909 0001 was delivered in error and was ineffective.

**IT IS ORDERED THAT:**

- 6 In respect of the First Claimant:
  - (a) the MR04s filed in respect of charges 0367 1097 0005 and 0367 1097 0006 be removed from the register; and
  - (b) the charges be marked as outstanding.
- 7 In respect of the Second Claimant:
  - (a) the MR04s filed in respect of charges 0417 9375 0003, 0417 9375 0004 and 0417 9375 0005 be removed from the register; and

(b) the charges be marked as outstanding.

8 In respect of the Third Claimant:

(a) the MR04 field in respect of 0765 9577 0004 be removed; and

(b) the charge marked as outstanding.

9 In respect of the Fourth Claimant:

(a) the MR04 filed in respect of charge 0765 9581 0002 be removed;

(b) the charge be marked as outstanding.

10 In respect of the Fifth Claimant:

(a) the MR04 filed in respect of charge 0750 4909 0001 be removed from the Register;

(b) and the charge be marked as outstanding.

11 The Claimants are to deliver a sealed copy of this order to the Defendant within 14 days of receipt of the sealed order.
