Jascom Electrical Contractors Limited (Under A Company Voluntary Arrangement) ("CVA") Medway County Court No 8 of 2005

In accordance with Rule 1.26(2) of the Insolvency Rules 1986 it is the Joint Supervisors' duty to prepare an abstract of receipts and payments and report to all creditors on the progress of the Voluntary Arrangement at least once in every 12 months beginning with the date of appointment.

Accordingly, we set out below our report on the progress of the arrangement, and enclose a receipts and payments account for the year ended 2 June 2009 for your attention.

1. Voluntary Contributions

Creditors will recall that under the terms of the CVA the company is obliged to pay voluntary contributions totalling £216,000 by way of monthly payments of £3,000 per month for the first two years and £4,000 for the succeeding three years.

As at 2 June 2009 the sum of £156,000 was paid to the Joint Supervisors, which is in line with the proposals. A further contribution was paid in June 2009 and July 2009 bringing total contributions to date of £164,000.

2. Surplus Income/Additional Contributions

The arrangement, approved by creditors, specified that the Supervisor should review the company's income and expenditure every 6 months and obtain an increase in voluntary contributions of not less than 50% of any rise in the net income after provision for tax. The level of surplus income has been monitored and the company has been providing Management Accounts on a regular basis to assist in this process.

Accounts have been supplied for the year ending 31 March 2008. We are currently awaiting the annual accounts for the period 31 March 2009.

In addition, the company's business loan was satisfied in May 2007. As at 2 June 2009, the sum of £14,532 was paid to the arrangement by way of additional contributions. Further contributions have been paid in June 2009 bringing total additional contributions to date of £15,224. The sum of £692.00 will be paid on a monthly basis for the remaining term of the Arrangement.

Scheme Creditors

Preferential Creditors

There are no preferential creditors.

Unsecured Creditors

H M Revenue & Customs have submitted claims for PAYE/NIC and VAT. These claims amount to £68,515.50 and £83,856.16 respectively. In addition, I have received 25 unsecured creditor claims to date in the sum of £57,816.01. Three creditors have yet to prove their claims, which were recorded on the directors' statement of affairs at a total of £610.73.

4. Distribution of Funds

Unsecured distributions of 10p, 17p and 30p in the £ were declared on 1 September 2006, 1 August 2007 and 15 September 2008 respectively.

Those creditors who have not proved their claim in the Arrangement will find enclosed with this report a Notice of Intended Dividend.

5. Joint Supervisors' Remuneration

The manner in which the Joint Supervisors should be remunerated is set out in the directors' proposals, being on a time costs basis. As at 28 July 2009, our time ledger stood at £16,071.00 plus VAT in respect of the Arrangement, which equates to 113.75 hours spent on the administration of the CVA. To date, we have drawn the sum of £14,500.00 plus VAT, leaving an outstanding undrawn balance of £1,571.00.

A schedule setting out details of the time costs incurred from 3 June 2005 to 28 July 2009 by classification of work is enclosed, in accordance with the requirements of the revised Statement of Insolvency Practice 9 "Remuneration of Insolvency Office Holders ("SIP 9") which came into force with effect from 1 January 2003.

6. Disbursements

Creditors will be aware that the manner in which the Joint Supervisors should draw disbursements is set out in the directors' proposals. Expenses have been re-charged to the Arrangement for specific bond, room hire and company search, as shown on the attached Income and Expenditure account.
