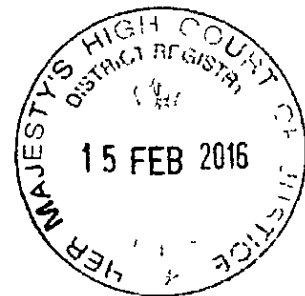

ORDER

Before District Judge Goldberg sitting at Leeds District Registry on 12 February 2016

UPON THE APPLICATION of Julian Nigel Richard Pitts, Adrian Graham and Edward Klempka
AND UPON reading the witness statement of Julian Nigel Richard Pitts dated 4 February 2016
AND UPON reading letters from Gerald Krasner and Robert Sadler
IT IS HEREBY ORDERED as follows:

- 1 In respect of those Administrations, Bankruptcies, Individual Voluntary Arrangements, Creditors Voluntary Liquidations, Members Voluntary Liquidations and Compulsory Liquidations as listed in the Schedule to this Order and which are the subject of proceedings in County Courts, the Companies Court or other District registries in England and Wales, those proceedings be transferred to the High Court, Chancery Division, Leeds District Registry solely for the purpose of this Application and thereafter transferred back to the relevant Court

Order applicable to cases listed in Schedule 1 only

- 2 Julian Nigel Richard Pitts be removed from office as Administrator, Liquidator and Supervisor (as the case may be) of those insolvency cases listed in Schedule 1 in respect of which he is shown as the joint officeholder with immediate effect
- 3 Edward Klempka be removed from office as Supervisor of the Individual Voluntary Arrangement of John Peter Mason (Deceased) being the last named insolvency case in Schedule 1 with immediate effect.
- 4 Julian Nigel Richard Pitts and Edward Klempka be granted their release or discharge from all liability as appropriate 21 days after the publication in the London Gazette and/or the filing with the Registrar of Companies and/or the notification to the Secretary of State as necessary as required by paragraph 9 below, without being required to apply for his release or file a receipts and payment account.

Order applicable to cases listed in Schedule 2 only

- 5 With immediate effect Adrian Graham be removed from office as Supervisor and Julian Nigel Richard Pitts be appointed in his place in respect of those cases listed in Schedule 2
- 6 Adrian Graham be granted his release or discharge from all liability as appropriate 21 days after the publication in the London Gazette and/or the filing with the Registrar of Companies and/or the notification to the Secretary of State as necessary as required by paragraph 9 below, without being required to apply for his release or file a receipts and payment account.

Order applicable to cases listed in Schedule 3 only

- 7 Adrian Graham be removed from office as Supervisor of those cases listed in Schedule 3 with immediate effect
- 8 Adrian Graham be granted his release or discharge from all liability as appropriate 21 days after the publication in the London Gazette and/or the filing with the Registrar of Companies and/or the notification to the Secretary of State as necessary as required by paragraph 9 below, without being required to apply for his release or file a receipts and payment account.

Applicable to all cases listed in Schedules 1 to 3

- 9 The relevant Applicant or Respondent, as the continuing or replacement office holder of the relevant estate shall as soon as reasonably practicable and in any event, within 14 days of receipt of the sealed Order
 - 9.1 publish in the London Gazette one composite notice relating to all new appointments which are required by law to be published in the London Gazette;
 - 9.2 file with the Registrar of Companies any notices in respect of the removal of Messrs Pitts, Graham and Klempka (the resigning office holders) which are required by law to be so filed;
 - 9.3 Without incurring any additional expense to any of the said estates:
 - 9.3.1 Notify the Secretary of State of the making of this Order, and
 - 9.3.2 Notify creditors (and members where appropriate), in their next routine report, of the making of this Order and provide an explanation of the effect of this Order including specifically referring to creditors' liberty to apply to discharge or vary this Order
- 10 Subject to paragraphs 11 and 14 below, in the event that, as a result of the implementation of the Order, any additional costs are incurred in the administration of the insolvent estates (that is to say over and above those costs incurred in the ordinary course of the administration of those estates), those costs shall be borne by the relevant firm of the continuing or replacement office holder and shall not be charged as an expense of those estates
- 11 Nothing contained in paragraph 10 shall prejudice the Applicants or the Respondents from.
 - 11.1 charging to each individual estate the cost of obtaining an Insolvency Practitioners licence bond in respect of that estate; and

- 11.2 apportioning equally between the relevant estates the cost of the composite London Gazette notice under paragraph 9 above.
- 12 Rules 2 47(3A), 4.49B(5), 4 49C(3)(a) and 6 78A(4) of the Insolvency Rules 1986 shall not apply as a consequence of this Order
- 13 Liberty to each creditor of each estate to apply to vary or discharge this order within 21 days of the receipt of the notice directed to be sent under paragraph 9 above
- 14 The cost of this application (including VAT) be aggregated and apportioned equally between each of the estates listed in the Schedules to be drawn as disbursements as and when sufficient funds are available.
