- (5) the Registrar of Companies do advertise notice of this Order in his official name in the "London Gazette",
- (6) in the event that the Claimant fails to comply with undertaking (C) above the Registrar of Companies be at liberty to commence strike off action in respect of the Company without further notice to the Claimant
