**Post Balance Sheet Event**

On 6 August 2009, ITV plc exchanged sale contracts with brightsolid Limited regarding the acquisition of Friends Reunited Holdings Limited and all subsidiaries for £25 million. Following final regulatory approval from the Competition Commission, the sale completed 25 March 2010. The Friends Reunited Group is now 100% owned by brightsolid Limited.
