  - (b) In accordance with section 95(1) of the Act, the pre-emption provisions contained in sections 89 to 94 of the Act shall not apply to the allotment of the 499,999 ordinary shares of 10p each referred to in paragraph (a) and, instead, the directors be and hereby authorised and directed to allot those shares in accordance with the Share Exchange Agreement.
