Basis of preparation

The accounts are prepared under the historical cost accounting rules and in accordance with the Financial Reporting Standard for Smaller Entities.

Fixed assets and depreciation

Depreciation is provided by the Company to write off the cost less the estimated residual value of tangible fixed assets by equal instalments over their estimated useful economic lives as follows:
