1. Introduction

- 1.1 The affairs of the Companies are now concluded and this is the Joint Liquidators' account of the winding-ups, showing how they have been conducted.
- 1.2 The purpose of this report is to detail the Joint Liquidators' acts and dealings together with the conduct of the Joint Liquidators during the Liquidations since the Appointment Date.
- 1.3 The appendices attached form part of the Final Account for the Companies and should be read as a whole.

2. Progress of the Liquidations

2.1 The manner in which the affairs and business of the Companies have been managed and financed during the Reporting Period are set out below.

Coleridge (Dormants) Limited, D.U.K.E. (Enfield) Limited, D.U.K.E. Residential (UK) Limited, MB NA1 Investments Limited and Rokval (Bournemouth) Limited

- 2.2 According to the DoS, these entities had no assets at the Appointment Date.
- 2.3 However, Coleridge (Dormants) Limited received a distribution in specie of £1,000, from Sterling Valad (Teesdale) Limited at a rate of £1 per ordinary A and B share. This amount was subsequently distributed in specie to D.U.K.E. Property Holdings (UK) Limited, as sole member, during the Reporting Period.

Fountains Walk Trustee Limited

2.4 According to the DoS, this entity had a debtor balance of £1 at the Appointment Date, relating to unpaid share capital. This amount has been distributed in specie to the member of this entity, Fountains Walk Limited.

Sterling Valad (Teesdale) Limited

According to the DoS, this entity had a debtor balance of £1,000 on the Appointment Date, relating to unpaid share capital. This amount has been distributed in specie to the member of this entity, Coleridge (Dormants) Limited during the Reporting Period.

Other Matters

- 2.6 The Joint Liquidators have obtained Corporation Tax, VAT and PAYE clearance from HMRC in respect of the Companies during the Reporting Period.
- 2.7 There are no other known matters or assets to be dealt with. There will be no further asset realisations.

3. Liabilities and Dividends

Creditors

3.6 As detailed above, amounts totalling £1,000 were distributed in specie to the member of this entity, Coleridge (Dormants) Limited (In Members' Voluntary Liquidation). There will be no further distributions.

4. Joint Liquidators' Costs and Expenses

- 4.1 The Joint Liquidators' remuneration and disbursements were previously authorised by the Members by written resolution prior to the Appointment Date. It was agreed that the Joint Liquidators' remuneration would be fixed at £2,500 plus disbursements and VAT for each entity.
- 4.2 The Joint Liquidators' fees of £2,500 and disbursements of £445 per entity (total fees of £17,500 and total disbursements of £3,115) have been paid directly to Duff & Phelps by D.U.K.E. Real Estate Ltd, an associated entity.
- 4.3 The Joint Liquidators have not incurred any expenses in the Reporting Period.

5. Joint Liquidators' Final Receipts and Payments Accounts

5.1 Final receipts and payments accounts for the Reporting Period for each of the Companies are shown at Appendix 1. There is a nil balance in respect of each Liquidation.

6. Conclusion

6.1 The Joint Liquidators have completed their administration of the Liquidation, and no further reports will be issued. The Joint Liquidators' vacation of office and release from liability will follow. It is expected that the Company will proceed to dissolution within the next six months.
