**1. ACCOUNTING POLICIES**

**Accounting convention**

The financial statements have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008).

The company was dormant throughout the current year and previous year.

**Service Charges**

The company is responsible for the management of Mead Court (Kingsmead) Management Trust and collects service charges from the lessees in order to fund expenditure incurred in the management of the properties. These service charge funds are held in trust for the lessees as required by the Landlord & Tenant Act 1987. Transactions relating to the management of the properties are reported separately to the lessees and are excluded from the company's financial statements.

**Bank balances held in trust**

The company operates bank accounts which hold service charges in trust for the benefit of the lessees of the properties managed by the company. The amounts held on account at 31 December 2013 amounted to £17,751.
