1. ACCOUNTING POLICIES

Accounting convention

The financial statements have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective January 2007).

Deferred tax

Deferred tax is recognised in respect of all timing differences that have originated but not reversed at the balance sheet date.

Investments

Investments held as fixed assets are stated at cost less provision for permanent diminution in value. Those held as current assets are stated at the lower of cost and net realisable value.

Income from investments

Investment income comprises dividends received during the accounting period and interest receivable on listed and unlisted investment.

Dividends are brought to account in the profit and loss account when received.

Consolidation

The company and its subsidiary undertaking form a small group as defined by statute and therefore the company has taken advantage of the exemption under section 248 of the Companies Act 1985 not to prepare group financial statements.
