The Directors present their Annual Report on the affairs of the Company, together with the financial statements for the year ended 30 June 2014.


### **Principal activities**

### 4. Ultimate parent undertaking

The Company is a wholly-owned subsidiary undertaking of British Sky Broadcasting Limited, a Company incorporated in the United Kingdom and registered in England and Wales.
