Directors' report

Principal activities, business review and future developments

Following the completion of the sale of the Dentsu Aegis Network (formerly Aegis Group plc) shares to Dentsu Inc. on 26 March 2013 the ultimate parent company is Dentsu Inc.

The Company did not trade during the year. As a result, these financial statements are prepared on a basis other than going concern.

The balance sheet on page 5 of the financial statements shows the Company's financial position which consists principally of an intercompany receivable from Dentsu Aegis London Limited (formerly Dentsu Aegis UK Limited) as a result of the sale of trade and net assets.

Financial risk management objectives and policies

The directors consider that the only significant financial risk to the Company is credit default risk in relation to the intercompany receivable. The directors consider the risk of credit default to be remote.

The Company does not use financial instruments.

Results and dividend

The profit on ordinary activities for the year after taxation was £Nil (2013: £Nil).

A dividend of £Nil (2013: £Nil) was paid. No final dividend is proposed.

The Company's directors believe that further key performance indicators for the Company are not necessary or appropriate for an understanding of the development, performance or position of the business as a result of the sale of the trade and net assets on 31 December 2008.

The Company sold its trade and net assets at the 31 December 2008 to Dentsu Aegis London Limited (formerly Dentsu Aegis UK Limited), its immediate parent company, and has not traded during the year. As required by FRS 18 Accounting Policies, the directors have prepared the financial statements on a basis that the Company is no longer a going concern.

Cash flow statement

The financial statements of Dentsu Aegis Network Limited for the year ended 31 December 2014 contain a consolidated statement of cash flows. Therefore the company has taken advantage of the exemption granted under FRS 1 (revised) whereby it is not required to publish its own statement of cash flows.
