- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the Company will continue in business.



1. General information

The Company did not trade during the period.

The Company is a private Company limited by shares and is incorporated and domiciled in England. The address of its registered office is 7th Floor 1 Minster Court, Mincing Lane, London, EC3R 7AA.

2. Accounting policies

2.1 Basis of preparation of financial statements

The financial statements have been prepared under the historical cost convention and in accordance with Financial Reporting Standard 102, the Financial Reporting Standard applicable in the United Kingdom and the Republic of Ireland and the Companies Act 2006.

The preparation of financial statements in compliance with FRS 102 requires the use of certain critical accounting estimates. It also requires management to exercise judgment in applying the Company's accounting policies (see note 3).
