## Principal activities

An agreement was entered into on 22 December 2006 under which LST SMIF Limited Partnership acting by its general partner, LST SMIF Partnership GP Limited, conditionally undertook to acquire the entire issued share capital of SMIF Investments Luxembourg Sarl (formerly Starsmif Investments Luxembourg Sarl), the ultimate controlling undertaking Completion occurred on 2 February 2007 and the ultimate controlling party is Land Securities Group PLC

#### Results and Dividends

The loss for the year of £2 has been transferred to reserves. During the year, the directors recommended and paid a dividend of £166

# 1 Accounting policies

## Accounting convention

The financial statements are prepared on the going concern basis, under the historical cost convention, and in accordance with applicable UK Accounting Standards

#### Investment income

Investment income includes dividends receivable and interest receivable. Dividends are recognised when the right to receive payment is established. Interest receivable is included in income on an accruals basis.

## Fixed assets - Investments

Investments are stated at cost less any provision for impairment. Interest income is accounted for on an accruals basis

#### Cash flow statement

The company has taken advantage of the exemption conferred by Financial Reporting Standard 1 from preparing a cash flow statement, as it is a 90 per cent controlled subsidiary of SMIF Investments Luxembourg Särl (formerly Starsmif Investments Luxembourg Särl) and its results are included in the consolidated financial statements of SMIF Investments Luxembourg Särl

#### 11 Controlling party

As at 31 December 2006, the immediate parent undertaking was Secondary Market Infrastructure Fund UK LP and the ultimate parent undertaking and ultimate controlling party was SMIF Investments Luxembourg Särl (formerly Starsmif Investments Luxembourg Särl), a company incorporated in Luxembourg

The largest and smallest group to consolidate these financial statements is SMIF Investments Luxembourg Sarl

The company is not required to prepare consolidated financial statements as its results are included in the consolidated financial statements of SMIF Investments Luxembourg Sarl
