**1 Statutory information**

INDEPENDENT STREET ARTS NETWORK is a private company, limited by shares, registered in England and Wales, registration number 04316026. The registered office is 54 CHALTON STREET, LONDON, NW1 1HS.

**2 Average number of employees**
