Report of the Directors For the Year Ended 31 December 2014

The directors present their report with the financial statements of the company for the year ended 31 December 2014.

PRINCIPAL ACTIVITY

The principal activity of the company in the year under review was that of general partner of the RisingStars Growth Fund, a Limited Partnership registered under the Limited Partnership Act 1907.

The company qualifies as small in accordance with the provisions of s382(3) of the Companies Act 2006 and is therefore exempt from the requirement to present an enhanced business review and exemption from preparing a Strategic Report.

REVIEW OF BUSINESS AND FUTURE DEVELOPMENTS

The results for the year and financial position of the company are as shown in the annexed financial statements. The directors do not expect a significant change in the activities of the business in the future and look forward to the future with confidence.

In considering the appropriateness of the going concern basis, the directors have reviewed the company's on-going financial commitments for the next 12 months and beyond, including the company's working capital requirements. As a result the directors have satisfied themselves that it is appropriate to prepare these financial statements on a going concern basis.

STATEMENT OF DIRECTORS' RESPONSIBILITIES



We have audited the financial statements of Enterprise Ventures (General Partner RisingStars) Limited for the year ended 31 December 2014, which comprise the Profit and Loss Account, the Statement of Total Recognised Gains and Losses, the Balance Sheet and the related notes 1 to 9. 1. ACCOUNTING POLICIES

The financial statements have been prepared in accordance with applicable law and accounting standards in the United Kingdom. A summary of the principal accounting policies applied consistently in both the current and prior year is set out below. The company qualifies as small in accordance with the provisions of s382(3) of the Companies Act 2006.

Accounting convention

The financial statements have been prepared under the historical cost convention.

In considering the appropriateness of the going concern basis, the directors have reviewed the company's on-going financial commitments for the next 12 months and beyond, including the company's working capital requirements. As a result the directors have satisfied themselves that it is appropriate to prepare these financial statements on a going concern basis.

Turnover

Turnover represents income due from the RisingStars Growth Fund, as a first charge on the net income and capital gains of the Fund.

Cash flow statement

The exemption available in FRS1 (Revised 1996) 'Cash Flow Statements' has been taken from preparing a cash flow statement on the grounds that the company is wholly owned within a group and consolidated accounts, which include this company's results, are publicly available.

2. STAFF COSTS

The directors did not receive any emoluments from the company during the current or previous year.

The company had no employees other than the directors in the current or previous year.

3. AUDIT FEES

The audit fee of £800 (2013: £780) is paid by the parent company and is not recharged.

4. TAXATION

No liability to UK corporation tax arose on ordinary activities for the year ended 31 December 2014, nor for the year ended 31 December 2013.
