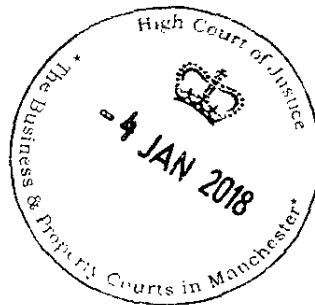

UPON the application of Peter Kubik and Michael Kiely dated 18 December 2017

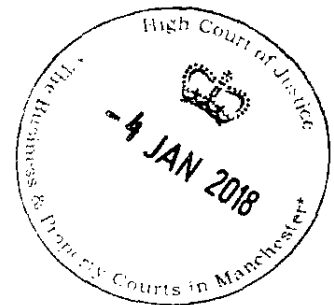
AND UPON reading the First Witness Statement of Peter Kubik with Exhibit PK1 dated  
11 December 2017

IT IS ORDERED THAT:

- 1 Each of the County Court cases listed in Schedule 1 (attached to this order) be transferred to the High Court of Justice, Business and Property Court in Manchester, Insolvency and Companies List (ChD) for the purpose only of making this order.
- 2 Immediately upon this order taking effect, the County Court cases listed in Schedule 1 (attached to this order) be transferred back to the County Court.
- 3 Andrew Andronikou ("**Outgoing Officeholder**") be removed from office in respect of each of the cases listed in Parts 1, 2 and 3 of Schedule 2 (attached to this order) ("**Block Transfer Cases**") from the date of this order.
- 4 Peter Kubik be appointed as joint replacement officeholder in respect of each of the Block Transfer Cases listed in Part 1 of Schedule 2 from the date of this order.
- 5 Michael Kiely be appointed as joint replacement officeholder in respect of each of the Block Transfer Cases listed in Part 2 of Schedule 2 and as sole replacement officeholder in respect of each of the Block Transfer Cases listed in Part 3 of Schedule 2 from the date of this order.
- 6 The creditors in each of the Block Transfer Cases listed in Schedule 2 be notified of this order by advertisement in the London Gazette within 14 days of the date of the order and at the time of the next statutory reporting requirement for each case.
- 7 Any creditor in respect of any of the companies or persons listed in Schedule 2 who has an objection to this order shall have 28 days from the date of the advertisement in accordance with the preceding paragraph to apply to court to set aside or vary the terms of this order. Such application shall not affect the transfer of the Block Transfer Cases listed in Schedule 2 until further or other order by the court.
- 8 Peter Kubik shall give notice to the Secretary of State and the Registrar of Companies in respect of the liquidations and administrations listed in Part 1 of Schedule 2 of the terms of this order as soon as reasonably practicable.
- 9 Michael Kiely shall give notice to the Secretary of State and the Registrar of Companies in respect of the liquidations and administrations listed in Part 2 and 3 of Schedule 2 of the terms of this order as soon as reasonably practicable.
- 10 The Applicants shall file a copy of this order with each of the courts listed in Schedule 1.

- 11 The Outgoing Officeholder shall receive his release as administrator, liquidator, trustee in bankruptcy and individual voluntary arrangement supervisor respectively 28 days after the giving of notice to creditors in accordance with this order, save that such release may be subject to further order in the event of an application by any creditor under paragraph 7 of this order for the specific case subject to that application.
- 12 The costs of this application shall be paid as an expense and shall be apportioned equally between each of the block transfer cases so that the estate of each block transfer case shall bear an equal proportion of the costs.
- 13 Such further order or other relief or direction as the court shall deem fit.

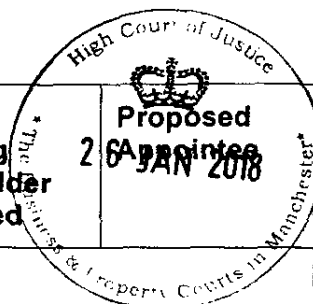
