#### Year ended 31 May 2015

During the year the covenants on the loan facilities were breached and the lender has taken enforcement action against other subsidiaries party to the cross guarantee. The total borrowings secured under the cross guarantee of approximately £310m are expected to significantly exceed the value of the assets available to make repayment.

As a result of this the directors are unable to presume that the company will continue to be a going concern. The directors do not believe the going concern basis to be appropriate and therefore these financial statements have not been prepared on a going concern basis.
