- 3 That the Articles of Association be and are hereby amended as follows

 - "25 There shall be a maximum of nine trustees unless otherwise determined by ordinary resolution of the members of the Charity Of the nine trustees, three shall be ex officio the chairman from time to time of each of Severn Valley Railway (Holdings) pic, Severn Valley Railway Company Limited and Severn Valley Railway Association or if any such chairman does not wish to act as a trustee, such other person nominated by such chairman to act as trustee Such a trustee (whether a chairman or his nominee) shall be referred to as an "ex officio trustee" Any person nominated by a chairman to act as trustee may from time to time be removed and replaced by his appointor. Up to six trustees shall be elected as provided subsequently in these Articles ("the elected trustees") "
 - by the deletion in Article 29 of the word "quarter" and the insertion in its place of the word "third"
 - by the insertion at the end of Article 31 of the following "or unless the trustee has already served a term of 6 or more years as a trustee and the trustees have not resolved that he should be reelected"
