



1. By way of legal mortgage the Property (including any buildings constructed thereon); and

2. By way of floating charge the whole of the Chargor's undertaking and all its other property and assets (collectively the Chargor's Assets)

The Property is the Leasehold premises known as Rivington Place Car Park Site, Rivington Place, Shoreditch, London, EC2 and registered under Title Number EGL447725.

Details of the Lease under which the Property is held are contained in the Schedule of the Legal Charge and are as follows:

The Lease of the Property was made on 30 August 2002 between Shoreditch Town Hall Trust (1) and Albion Real Estate Inc. (2) for a term of 99 years less 3 days from 30 August 2002, with an Initial Rent of £1 (if demanded)

Section 2 of the Legal Charge also contains the following covenants on the part of the Chargor:

2.1 to use best endeavours to procure that the landlord (as defined in the Lease) insures the Property in accordance with the terms of the Lease and to request the landlord to produce within 5 working days of receipt of written demand details of the insurance policy together with evidence of payment of the current premium and to produce the said details and premium receipt to the Council within 5 working days of receipt

2.2 to keep the Property in good and sufficient repair throughout the Term in accordance with the terms of the Lease

2.3 to comply with the covenants and conditions on the part of the lessee contained in the Lease

The Council has the power to appoint a person to be a receiver under section 6 of the Legal Charge at any time after the security becomes enforceable or at the request of the Chargor of all or any part of the Property (whether or not an employee of the Council) and none of the restrictions imposed by the Law of Property Act 1925 in relation to the appointment of receivers or to the giving of notice or otherwise shall apply.
