TRUSTEES REPORT

Structure, Governance and Management

The Trustees submit their annual report and the audited financial statements of the charity for the year ended 31 March 2006. The charity is constituted as a company limited by guarantee. The financial statements are the full statutory financial statements of the charitable company and should be read in conjunction with the Annual Report.

Keystone Development Trust is a company limited by guarantee and a charity governed by Memorandum and Articles of Association. Originally named Keystone Community Partnership Development Trust Limited, Companies House approved a change of name to Keystone Development Trust on 23 April 2003. The directors of the charitable company are its Trustees for the purpose of charity law and throughout this report are collectively referred to as the trustees. There are currently twelve Trustees drawn from various backgrounds within the Keystone area of benefit. Details of Trustees, and other company information, is contained in page 1.

Trustees are appointed from within the membership, and externally, by a recruitment process which includes advertising and interview. The Chair is appointed by the trustees. New Trustees receive a briefing on their legal obligations under charity and company law, the content of the Memorandum and Articles of Association, the decision making processes, the business plan and recent financial performance of the charity. Trustees are also encouraged to attend appropriate external training events where these will help them to better understand their role.

The Board of Trustees administers the charity. The Board meets bi-monthly and there is a sub-committee covering finance and audit which meets twice during the year. A Chief Executive is appointed by the Trustees to manage the day to day operations of the charity. To facilitate effective operations, the Chief Executive has delegated authority, within terms of delegation approved by the Trustees, for operational matters including finance, employment and operations.

The Trustees have examined the major strategic, business and operational risks which the charity faces and confirm that systems have been established to enable regular monitoring so that the necessary steps can be taken to mitigate those risks.

Objectives and Activities

The Keystone vision is:

'To improve the quality of life and opportunities for people who live, study and work in the Keystone area through sustainable, community led regeneration. Working closely with partner organisations and communities, Keystone aims to ensure that the area is safe, healthy, inclusive, socially and economically vibrant.'

The Keystone aim is to:

'To build community capital, the collective skills, knowledge and experience, facilities and organisations which ensure greater returns in the quality of life for all, and to anchor community capital locally to ensure sustainable returns.'

In achieving this Keystone Development Trust aims to address issues which significantly affect the quality of life of the communities which it serves. It seeks to identify needs through research, consultation and discussion with partners and other organisations. Some of the current issues facing the area include:

- A significantly higher than average number of people both less than 16 years old and older than 60.
- The wards of Thetford-Abbey and Thetford-Saxon have twice the Norfolk average for the percentage of households consisting of lone parents living with dependent children.
- Figures from the Breckland Crime and Disorder Reduction Partnership show that 4 of Thetford's Wards are in the top 6 Breckland wards for reported crime.
- West Thetford exhibits a number of indicators of poverty. One of the Thetford Abbey Super Output Areas is in the top quintile of most deprived wards nationally for income, employment and multiple deprivation.
- Thetford has had persistent educational problems for a number of years. Poor
 educational performance feeds into other problems such as poverty and the
 performance of the local economy. Low educational attainment also contributes
 to the number of young people who become NEET (Not in Education,
 Employment or Training). Indicators of poor educational standards include:
 - ➤ In 2004 the two Thetford High Schools achieved GCSE pass rates of 25% and 23% against a national average of 54%
 - > The 2001 census shows that only 9% of people in Thetford have achieved a level 4/5 qualification (first degree and above) compared to 20% in England
 - > Two out of four wards have over 40% of people between 16-74 with no qualifications.
 - ➤ Only 2% in Abbey ward are employed in higher managerial posts compared to the national average of 9% whilst 39% are employed in routine or semi-routine posts compared to the national average of 21%

- > Low aspirations and low self-esteem are frequently reported in reviews about Thetford.
- Thetford and Suffolk have a higher than average employment in manufacturing but employment in this sector is predicted to fall by 13% by 2010.
- Adults living in Breckland are the least likely in Norfolk to access the internet providing obstacles in accessing local services, advice and training opportunities. This is also exacerbated by rural remoteness and a limited transport infrastructure.
- Average earnings without overtime in the Thetford Travel to Work Area for fulltime employees are £301 a week compared to the Norwich average of £345.
- According to local heath workers teenage conceptions have trebled in Thetford in the past five years.
- Unemployment in West Thetford is higher than both the Breckland and UK averages.
- Fast growing migrant worker communities from Portugal and Eastern Europe.
 This has led to worker exploitation, pressure on public services and tensions between communities.

Keystone works to develop projects and activities which can address these issues.

The objectives that we set for the last year were:

- To support the migrant worker communities and the integration into the indigenous community;
- To work with the communities in west Thetford to improve the facilities and services available:
- To provide vocational training opportunities in Thetford;
- To develop services that can be accessed by rural communities;
- To deliver high quality children's and youth activities;
- To work on breaking down inter-generational barriers;
- To develop social enterprises that meet local needs and / or provide income to the Trust; and,
- To develop support for the voluntary sector and encourage volunteering.

Keystone's overall strategy for addressing the above objectives consists of:

- Developing new projects which address identified local issues.
- Ensuring that existing projects are having an impact in addressing local needs and are delivered to the highest possible standard.
- Work in partnership where possible to ensure that there is not duplication of service.
- When appropriate, acting as an advocate on behalf of a particular community.
- Developing a financially sustainable organisation which, in time, will be able to fund its own community development work and be less reliant on external grants and funding.

Over 2005 – 6 our main projects and programmes have been:

- The Growing Together Single Regeneration Budget programme. Since April 2003 KDT has been Accountable Body for this programme. Now administered by the East of England Development Agency (EEDA) it provides funding for a number of Keystone projects including the Training and Enterprise Officer and Community Grants. It also provides funding for a number of external projects who have submitted successful bids to the scheme and match funding for European funded projects.
- The Enterprising Communities Community Economic Regeneration package. This is a major package of European Objective 2 funded projects that is delivered in partnership with Breckland Council and a number of '2nd tier' delivery partners. The package funds a number of KDT projects including the Community Development team, Social Enterprise development and Voluntary Sector Support. It has also funded the development of the Keystone Innovation Centre, our flagship business centre. The projects are match funded by the SRB programme.
- The Keystone Enterprise Factory is a refurbished factory building that has been funded through SRB and Objective 2 funding but is a separate project to the CER package above. It fulfils a number of roles including vocational training, social enterprise development and support for small business.
- Green Ventures is a furniture reuse social enterprise that started in January 2006 and received support from CRED, a lottery funding stream.
- The Breckland New Communities project is a project that supports migrant workers in accessing public services and employment. It is funded through the Home Office's Connecting Communities programme, the European Social Fund

and Breckland Council.

- Imagine Arts, a community arts project, is funded primarily through the Sainsbury's Monument Trust.
- Keystone Community Finance, our microfinance project is funded through the Esmeé Fairbairn and Peddars Way Housing Association.
- The Abbey Neighbourhood Centre is a community building that was transferred from Breckland Council and is located on the Abbey estate in Thetford. It provides a base for staff and projects and has been supported through the Enterprising Communities package.

Achievements and Performance

This section of the report details progress against the objectives set in last years annual report.

To support the migrant worker communities and the integration into the indigenous community

Keystone has continued to deliver the Breckland New Communities project which has now supported over 1000 beneficiaries. This has provided beneficiaries with support in accessing employment, public services and language courses. The project has also supported a number of voluntary groups and public services in reaching the migrant communities.

The project also supported the development of a group of volunteers who had set up their own initiative to support migrant workers – the Multi Lingual and European Thetford Association (META). Early in 2006 META was integrated into KDT to allow us to provide them with greater support. Their work has won them national recognition, including a volunteering award for one of the founders, Suzanne Vaz and a number of local authorities are interested in duplicating the model.

We have recently been successful in securing a further £180,000 for the project for the next three years from *Connecting Communities Plus*. This should allow us to continue our work in this area.

To work with the communities in west Thetford to improve the facilities and services available

In September 2005 Keystone opened the Abbey Neighbourhood Centre on the Abbey estate, a building that had been closed for a number of years. Breckland Council had funded the refurbishment of the building but wanted to hand the day to day management to the local community. After working with a local group for some time it was decided that KDT would own and manage the building on behalf of the local community. A local 'friends of' group formed to raise money and help with activities.

The building provides a base for the Keystone Community Development Team and is used for the delivery of some project activities such as bingo, children's work and a credit union collection point. It is also used by a number of other local groups including a church, keep fit and Sure Start. Local residents can also hire the building for a preferential rate. A community café runs twice a week and the first year of operation has been a great success.

Keystone has continued to support the residents groups on the west Thetford estates, primarily through the Saxon Community Development Worker (CDW). Over the last year the Saxon CDW has delivered a West Thetford Improvements project which focuses on the Redcastle and Barnham Cross estates. This has delivered a range of physical improvements to the estates including new signage, youth shelters, bins, benches and planting.

Imagine Arts delivered a project which provided soft play facilities outside the Abbey Neighbourhood Centre and also involved the community in painting the shop shutters on the Abbey shopping parade.

Finally, Keystone has brought Credit Union services to West Thetford, both in the Abbey Neighbourhood Centre and through the Peddars Way Housing Office.

To provide vocational training opportunities in Thetford

In September 2005 Keystone opened the Building Block Construction Training Centre, based within the Keystone Enterprise Factory. This is equipped to provide training up to Level 2 in Construction and Carpentry. Working in partnership with West Suffolk College, the Thomas Paine 6th Form and local schools 46 students made use of the facility over the academic year.

We also delivered 'Keystone Prospects' - a number of Level 1 courses that were funded through the CER Enterprising Communities package. These included Health and Social Care and Construction Skills and were attended by over 100 beneficiaries.

To develop services that can be accessed by rural communities

Keystone's work has primarily focused on the market town of Thetford as this is where the European Objective 2 funding is focused. However some of our projects do serve rural communities such as Imagine Arts, which has visited some rural schools over the last year. We have also undertaken some youth work in rural areas.

To deliver high quality children's and youth activities

Children and Youth services remain a high priority for Keystone and a major focus of our work. Over the last year we have delivered the following projects:

Big Sitting Room A converted shop unit on the Abbey Estate which offers a

safe place for twenty 11 – 18 year olds to socialise on two nights a week.

- Table Tennis club Working with NACRO a table tennis club has been set up at the Abbey Neighbourhood Centre aimed at young adults.
- Sk8 Keystone continues to support a group of young skaters in fulfilling their ambition of developing a new skatepark in Thetford. Over the last year they have made presentations to the local council and carried out a number of fundraising activities. They have also worked with a skate park manufacturer to develop a design that will be unique to this country. Funding bids have been prepared and we are now working with the local authority to finalise the site.
- Kollectiv The Kollectiv project is a music project that has 120 members and an
 average attendance of 23 at the monthly meetings. It provides workshops, gigs
 and encourages mutual support between young musicians. This year we have
 broadened out the workshops offered to include breakdancing and vocals and
 have linked up with other projects such as the Big Sitting Room. We have also
 seen two of the Kollectiv bands sign professional recording contracts.
- Imagine Arts Imagine Arts has continued its innovative work with schools which has previously won it praise from Ofsted. Over the last year it has:
 - Continued to work with local schools, engaging young pupils in inspiring creative activity
 - Delivered a very successful project on evacuation during World War 2, funded by Home Front Recall
 - O Delivered a 'Shop Shutter Art' project on the Abbey Estate
 - Delivered out of school 'Arts clubs' in Brandon and at the Abbey Neighbourhood Centre
 - O Created a 'Thetford Board Game' to assist with numeracy and literacy
- KTeam The KTeam has continued to deliver out of school and out of home play sessions. Weekly 'Kclubs' have been delivered on the Barnham Cross estate in Thetford. The project has also supported other one off events, including a summer programme.
- Digital Eye The Digital Eye is a new project that provides training in film, animation and photography. Using a converted bus it is a mobile project which has great versatility and can be delivered in a number of settings. A number of successful pilot sessions have been delivered with Film East and the BBC and a full programme is currently being developed.

To work on breaking down inter-generational barriers

A number of projects have contributed to this objective. Members of the Sk8 project have undertaken advocacy for a new skatepark including speaking to the town council. This had the effect of challenging pre-conceived conceptions on both sides of the table.

The Imagine Arts Home Front Recall project also included some cross generational work in its exploration of evacuation during World War 2.

A cross generational project has also been planned for the Barnham Cross estate looking at the history of the estate.

To develop social enterprises that meet local needs and / or provide income to the Trust

Over the last year Keystone has developed and supported the following social enterprises:

- Green Ventures Green Ventures is Keystone's Furniture Reuse social enterprise. It collects unwanted furniture and sells it on at a reasonable cost to low income families. Having started in Jan 2006 it is currently being supported by a grant from the CRED lottery stream. It is hoped that by the time the grant runs out it will be a self sustaining social enterprise.
- Keystone Community Finance The Keystone Community Finance project has allowed Keystone to develop credit union services in Thetford for the first time, where there are known debt problems and active high interest lenders. A credit union is a savings and lending co-operative that is owned by its members. It is often the only financial service available to people who have been excluded from mainstream finance. Keystone has worked with Rainbow Savers Credit Union to open two collection points in Thetford. Although we have only been operating since Nov 2005 we already have over 80 members and the rate of growth is increasing.
- Abbey Neighbourhood Centre Operating without any kind of ongoing subsidy the Abbey Neighbourhood Centre is operating as a social enterprise. It will rely on a mixed income to survive in the future including rental of offices, hire fees and grants.
- Keystone Enterprise Factory The Keystone Enterprise Factory is a mixed use factory building that houses social enterprises, small businesses and other tenants. Originally supported through SRB and ERDF grants it is expected that it will be self sustaining once the grant funding expires.
- Keystone Innovation Centre Completed in May 2006 the Keystone Innovation Centre (KIC) is Keystone's flagship building. It is a new-build office development

that is intended to provide the Trust with a reliable income stream and strengthen the service sector in Thetford. The first building of its kind in the town it offers three storeys of high quality office space. It also has a café area and conferencing and meeting facilities. It is expected that these will operate as separate businesses and hopefully also generate further income for the Trust as well as providing local employment. Two tenants have already occupied the building including one that has moved from the St John's Innovation Centre in Cambridge.

 Hallmarks is an evaluation social enterprise which has been passed to Keystone to manage. Over the last year we have relaunched the website and been rebuilding the client base.

To develop support for the voluntary sector and encourage volunteering.

Keystone has continued to deliver its Voluntary Sector Support project as part of the Enterprising Communities European package. This provides support to local groups through the Thetford Area Voluntary Organisations network. The network contains over 89 local groups and 350 individuals. It provides support with funding, constitutional issues and training. It also facilitates regular network meetings and provides free Criminal Records Bureau checks for local volunteers.

Keystone all runs a Community Grants project which provides invaluable small grants for local voluntary and community groups. We also manage a community equipment library through which groups can borrow equipment for a small fee.

Finally Keystone also encourages volunteering within its own projects. Over the last year volunteers have supported a number of Keystone projects including Green Ventures, Breckland New Communities and Keystone Community Finance and with basic administrative and reception tasks. These volunteers are greatly valued by Keystone and provide an important resource.

Factors which affect the delivery of our objectives include:

- Ability to secure external funding The Trust is still reliant on external funding
 to undertake most of its work. IT does not receive any significant regular
 contributions from local authorities and most funding has to be secured through
 competitive processes.
- Success of Trust social enterprises If the Trust's social enterprises are successful then they will help to consolidate the core of the charity.
- Reputation with the local community The success that Keystone has had in engaging local people is partly due to the trust that it has built up with the local community. Our ability to engage with 'hard to reach groups' is fundamental to our work and needs to be maintained in the future.

- Relationship with strategic partners Our relationship with other key actors in the area affects what role we have and our ability to secure funding to undertake new project activity. Partners include local authorities, EEDA and Government Office.
- **Relationship with delivery partners** Within some projects KDT is responsible for managing a 2nd tier partner who delivers part of the project. In such a situation it is essential that a good relationship is maintained.

Financial Review

Total income for the year amounted to £5,421,110. Expenses in relation to governance costs were £21,864 and costs in furtherance of the charity's objects amounted to £2,014,414. Unrestricted and restricted funds carried forward at the end of the year amounted to £42,007 and £5,683,552 respectively.

The main sources of income during the year were from the European Regional Development Fund (ERDF), European Social Fund (ESF), East of England Development Agency (EEDA) and Government Office for the East of England (GO East) and this funding enabled the organisation to undertake specific project work in order to deliver the objectives.

Some of the funding received is paid to third party organisations in the form of grants for the delivery of specific outputs. These grants are detailed in note 6 on page 25.

Reserves Policy

The Trustees are aware that SRB and European Objective 2 funding programmes will cease during the period up to 31 March 2007. It is therefore felt prudent to build up unrestricted reserves to cover at least three months basic running costs to ensure the core activities of the charity into the future. It has not been possible to increase the reserves during the year ended 31 March 2006 but the Trust will continue working to maximise unrestricted income from various sources in order to build up a level of reserve which will enable activity to continue.

Investment Policy

The Trustees have a policy of investing all available funds overnight in order to maximise the interest receivable. The nature of the funding received does not make it appropriate, at the present time, to commit funds to longer term investments.

Plans for Future Periods

The financial year 2006/7 will be a significant one for the Trust. It marks the end of our major sources of current funding, SRB and European Objective 2. This means that we are entering a period of consolidation for the Trust. It is a situation that we have been planning for the last three years but with no obvious replacement funding, Keystone is

likely to undertake fewer projects in the near future. Key priorities for the current year include:

- Undertaking the orderly closure of current programmes All European Objective 2 projects require specific closure reports to be written and this will be undertaken during the period. There is also a requirement for an evaluation of the SRB programme which will be undertaken prior to the end of the funding programme.
- Continue to develop Trust social enterprises In the absence of significant streams of grant funding the success of Trust social enterprises is central to the future of the charity. It is vital that the buildings perform to their maximum potential both in terms of social and financial return. We will also be working on developing new social enterprises.
- Secure succession funding for current projects or undertake a managed closure With funding for many projects coming to an end Keystone will be working to secure funding to continue key areas of work, particularly children and youth activities and voluntary sector support. Where funding can not be secured the projects will need to be closed in an orderly way.
- Develop ongoing projects Some of Keystone's projects will continue beyond 2006/7. These include Imagine Arts, Green Ventures and Breckland New Communities.
- Identify and develop new projects The ending of current project activity permits the opportunity to assess areas where the Trust should be active and to develop new project activity. For example, we have recently submitted a bid for a new project to address teenage parenthood, a significant issue in our area.

Statement of Trustees' Responsibilities

Company law requires the Trustees to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the charitable company and of the surplus or deficit of the charitable company for that period. In preparing those financial statements the Trustees are required to:

- select suitable accounting policies and then apply them consistently;
- · make judgements and estimates that are reasonable and prudent; and
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the company will continue in business.

The Trustees are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the charitable company and to enable them to ensure that the financial statements comply with the Companies Act 1985. They are also responsible for safeguarding the assets of the charitable company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

- · there is no relevant audit information of which the auditors are unaware; and
- all steps which they ought to have taken to make themselves aware of any relevant audit information and to establish that the auditors are aware of that information, have been taken.

Independent auditors report to the members of Keystone Development Trust

1 Accounting policies

Basis of accounting

The financial statements are prepared under the historical cost convention, and have been prepared in accordance with the Companies Act 1985 and applicable accounting and financial reporting standards including the Statement of Recommended Practice (SORP) - 'Accounting and Reporting by Charities', (revised 2005).

Company status

The charity is a company limited by guarantee. The members of the company are the Trustees, as named on page 1. In the event of the charity being wound up, the liability in respect of the guarantee is limited to £1 per member of the charity.

Incoming resources

All incoming resources are included in the SOFA when the charitable company is legally entitled to the income and the amount can be quantified with reasonable accuracy. Donations in kind are recorded at their estimated value where material. Income is shown gross of all expenditure.

No amounts are included in the financial statements for services donated by volunteers.

Resources expended

Expenditure is recognised on an accruals basis and when a liability is incurred. Expenditure is shown exclusive of VAT where applicable. Direct charitable expenditure and costs of generating funds are allocated to the function in which they arise. Costs relating to premises are attributed to projects based on the number of people based in them, all other costs attributed to projects are based on incurred costs which are identifiable to each specific project. Support costs which cannot be attributed to specific projects are apportioned on the following basis:-

Staff costs
Premises costs
Communications

Time spent on the project
Employee numbers
Employee numbers

Postage & Stationery etc Employee numbers
Finance & professional fees Employee numbers

Grants payable are charged in the year in which the offer is conveyed to the recipient, except in those cases where the offer is conditional, such grants being recognised as expenditure when the conditions attaching are fulfilled.

1 Accounting policies (Continued)

Tangible fixed assets and depreciation

Tangible fixed assets are stated at cost less depreciation. Tangible fixed assets costing more than £500 are capitalised.

Depreciation is provided at rates calculated to write off the cost, less estimated residual values, of all fixed assets, except freehold land, evenly over their expected useful lives. It is calculated at the following rates:-

Freehold buildings - over 50 years

Machinery and office equipment - over 5 years

Vehicles - over 4 years

Computer hardware and software - over 3 years

The need for any fixed asset impairment write down is assessed by comparison of the carrying value of individual assets against the higher of realisable value and value in use.

Fixed asset investments

Fixed asset investments are stated at cost less provision for permanent diminution in value.

Funds

Restricted funds are funds where the purpose for which they can be used has been restricted by the provider.

Unrestricted funds are funds which can be used for any of the charity's operations at the Trustees' discretion.

The funds held in each of the categories are further described in note 18.

Pension costs

A number of the charitable company's employees contribute to a stakeholder pension scheme. Contributions by the charitable company to this scheme are charged to the profit and loss account when due.

Taxation

The charitable company is not liable for assessment to taxation on its results and recoverable income tax is accrued within the financial statements.

Keystone Communities

The funds provide support for communities and groups to help themselves build the capacity of neighbourhoods through projects like TAVO, META, community grants and community finance.

Keystone People

To support individuals by building their capacity and capabilities through projects like Prospects where training is provided for people out of work or wanting to improve their employment status and also through the building block where carpentry and bricklaying courses are provided.

Keystone Enterprise

Supports the development of social enterprises in the local area, together with starting up and running the trusts own enterprises that include Green Ventures, a furniture recycling business and Community transport.

Keystone Property

A diverse portfolio of buildings owned by the trust through which income is generated and space provided to projects for them to carry out their work.

Keystone Resources

The trusts core team that provides advice and support to the organisation through services such as finance, human resources and facilities management.

A more detailed review of each fund can be found in the trustees report.

Many of the projects included in the funds above are funded through programmes that include the Community Economic Regeneration programme utilising ERDF (European Regional Development Funds) and ESF (European Social Funds) funding and the Single Regeneration Budget, a source of funding received via the East of England Development Agency.
