

- 2. By way of fixed charge –
- all other freehold, leasehold and other immovable property now or in the future belonging to the Company together with all buildings trade and other fixtures, fixed plant and machinery of the Company from time to time thereon;
- all plant and machinery now or in the future belonging to the Company other than fixed plant and machinery;
- all cash at bank, book debts and other debts now or in the future due or owing to the Company;

accept surrenders conferred by Sections 99 and 100 of the Law of Property Act 1925 provided that such restrictions shall not be construed as a limitation on the powers of any receiver appointed under the Debenture and being an agent of the Company and M H Preece & Co may grant or accept surrenders of leases without restriction at any time after M H Preece & Co shall have demanded the payment or discharge of any monies obligations and liabilities secured by the Debenture

(d) pull down or remove or redevelop or make any material alteration to the whole or any part of any buildings or sever unfix or remove any fixtures or remove any plant or machinery belonging to or in use by the Company except for the purpose of effecting repairs or replacing the same
