The directors are responsible for preparing the Report of the Directors and the financial statements in accordance with applicable law and regulations.



### **TO THE MEMBERS OF**

We have audited the financial statements of Ambrosden (No2) Residents Company Limited for the year ended 31 March 2016 on pages 6 to 12. **Service charge income**
