INFORMATION REQUIRED TO COMPLY WITH SECTION 291 (4) OF THE COMPANIES ACT 2008

1) Eligible members are the members who would have been entitled to vale on the resolution on the circulation date of the written resolution.

The circulation date of the written resolutions is 21" January 2009 (the "Circulation Date")

The procedure for signifying agreement by an eligible member to written resolution is as follows: A member signifies his agreement to proposed written resolutions when the Company receives from him (or someone acting on his behalf) an authenticated document -

identifying the resolutions to which it relates, and

indicating his agreement to the resolutions (B) The document must be sent to the Company in hard copy form or in electronic form.

A member's agreement to written resolutions, once signified, may not be revoked.

Written resolutions are passed when the required majority of eligible members have signified their agreement to them. The period for agreeing to the written resolution is the period of 28 days beginning with the Circulation Date (see Section 297 of the Companies Act 2008).
