Variation

Capital

On a return of capital, the holders of A Shares are entitled to 80% of the capital balance, which shall be divided amongst the holders of A Shares *pro rata* to the number of A Shares held by them. The holders of B Shares are entitled to 20% of the capital balance, which shall be divided amongst the holders of B Shares *pro rata* to the number of B Shares held by them.

Voting

At a general meeting, on a show of hands, each holder of A Shares shall have eighty votes and each holder of B Shares shall have twenty votes. On a poll, each holder of Shares shall have a vote for each Share of which he is the holder.
