Report of the Trustees.

The trustees, who are also directors of the company for the purposes of company law, of Age Concern Regional Support Services (South East), known as Age Concern in the South East, submit their report and financial statements for the year ended 31st March 2015.

Objectives and Activities

Principal activity

The principal activity of the charity in the year was to promote the relief of elderly people in any manner which now or hereafter may be deemed by law to be charitable in and around the South East of England

Objectives of the Charity

The charity promotes the wellbeing of older people across the South East of England and aims to help make their lives as fulfilling and enjoyable as possible.

This is a common objective of the 170 Age UK's across the United Kingdom providing support and a range of services to people over 50, who make up one third of the UK population.

The national census estimates that people over 50 will increase to 40% of the population over the next 20 years.

Strategic direction of the charity

The trustees have confirmed the following general goals of the charity.

To maintain its position as a respected and acknowledged authority representing the interests of older people within the South East region

To develop closer links/partnerships with other groups concerned with the needs of older people including friends of Age UK.

To build upon the friendly relationships established with Age UK groups across the region In conjunction with the Age UK network in the South East, to review and develop service provision for older people, with the emphasis on providing good quality services at reasonable prices, where there is significant unfilled demand.

To ensure that the charity is financially self-sustaining and has sufficient resources in terms of both income and reserves to meet on-going and future client needs and to maintain a loyal and well-motivated staff and volunteer force

To play a positive role in supporting the needs of older people across the UK as an active part of Age UK.

Delivery of Public Benefit

In line with members of the Age UK Association, this charity adopts the common charity objectives, focusing on older people and their standards of life fulfilment and enjoyment.

The charity aims to work in cooperation with other organisations, statutory, commercial and voluntary to support older people through a range of services.

Review of the year's activities

The Company continues to provide support to the South East Congress, the voice of Age UK's in the South East within Age UK, through the commissioning of administrative support and the distribution of travel bursaries to attendees at Congress meetings. The Congress is open to all Age UK's based in the South East. The Congress held three meetings in the year these being in June, September, November. The meetings are open to Chief Officers and Chairs or their nominees to ensure maximum attendance by the members of the Congress. During the financial year the amount of £955 was distributed in bursaries to the attendees of the Congress.

The trustees have agreed that Age UK West Sussex should organise a number of learning events for Information and Advice practitioners in the South East. A programme is currently being put together.

The company with the support of the South East Regional Congress agreed to provide funding for the Age Uks in the South East and SEEFA, the South East England Forum on Ageing, to undertake a project aiming to enhance later life. The working title for the project was 'Transforming not Excluding - the impact of information technology and innovation on later life'. A launch event for the project was held on the 7th November at Woburn House culminating in a symposium held in the House of Lords on the 8th January. As a result of these meetings a report summarising the key issues identified as being in need of urgent around the impact of Information technology on later life was published in May 2015. SEEFA's Digital Inclusion Action Group is continuing the work in this area.

The Company is committed to support the work of the South East Congress through administrative support and the provision of travel bursaries. Following on from the successful work with SEEFA the Board is looking at how to further utilise the funds of the company for further joint working.

1, Accounting Policies

Accounting convention

The financial statements are prepared under the historical cost convention and in accordance with applicable Accounting Standards and the Charities SORP 2005 (Statement of Recommended Practice "Accounting By Charities" issued in March 2005) and the Charity's governing documents.

The Charity has a healthy bank balance and satisfactory reserves. No material uncertainties that may cast significant doubt upon the ability of the Charity to continue as a going concern have been identified by the Trustees. On this basis, the trustees consider that it remains appropriate to adopt the going concern basis in preparation of the financial statements.

Cash flow statement

Exemption has been taken from preparing a cash flow statement on the grounds that the company qualifies as a small company.

Resources expended

Liabilities are recognised as resources expended as soon as there is legal or constructive obligation committing the Charity to the expenditure.

All expenditure is accounted for on an accrual basis and has been classified under headings that aggregate all costs related to the category. No allocation of costs is required since all the costs can be allocated to the activity to which they relate.

Charitable activities are those incurred by the Charity in order to meet its charitable objectives, including support costs.

Governance costs comprise all costs involving the public accountability of the Charity and its compliance with regulation and good practice. These costs include costs relating to accountants fees, trustee meetings and legal fees.

Recognition of liabilities

These financial statements recognise all liabilities that the charity has responsibility for. The Charity is not aware of any contingent liabilities.

Funds held for restricted purposes

Restricted funds represent income received by the Charity for specific purposes or areas.
