



Notes to the financial statements For the year ended 31 December 2007

1. Principal accounting policies

These financial statements are prepared on the going concern basis, under the historical cost convention and in accordance with the Companies Act 1985 and applicable accounting standards in the United Kingdom. The principal accounting policies are set out below.

Financial instruments presentation

The Company has taken advantage of the exemption provided by FRS 25 for subsidiary undertakings of which 90% or more of the voting rights are controlled within the group of an ultimate parent that publishes consolidated financial statements which comply with the disclosure requirements of the standard, and therefore the disclosure requirements of the standard have not been adopted in these financial statements.

Related party disclosures

The Company has taken advantage of the exemption provided by FRS 8 for subsidiary undertakings of which 90% or more of the voting rights are controlled within the group of the ultimate parent which publishes its consolidated financial statements and has not disclosed transactions with other group companies.

Cash flow statements

The Company has taken advantage of the exemption offered by FRS 1 (revised) and has not produced a cash flow statement as it is a more than 90% owned subsidiary of a parent publishing consolidated financial statements.

5. Ultimate parent company and controlling party

The Company's immediate parent company is COLT Telecom Limited. On 30 June 2006, the Company's ultimate parent company and controlling party became COLT Telecom Group S A, a company registered in Luxembourg, following a Scheme of Arrangement involving the Company's former ultimate parent company, COLT Telecom Group plc. COLT Telecom Group S A is the parent undertaking of the largest group to consolidate these financial statements.

COLT Telecom Group plc was converted to a private limited company on 30 June 2006 and is the parent undertaking of the smallest group to consolidate these financial statements. Copies of COLT Telecom Group plc consolidated financial statements for years ended 31 December 2005 and prior are available from the Company's registered address at Beaufort House, 15 St Botolph Street, London EC3A 7QN. Copies of COLT Telecom Group S A's 31 December 2007 and 2006 consolidated financial statements are available from its registered office at K2 Building, Forte 1, 2a rue Albert Borschette, L-1246 Luxembourg, or from the Company's registered office as set out above.
