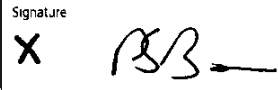
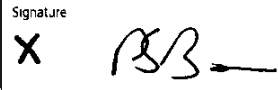
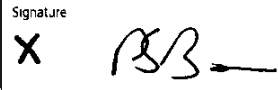

UPON THE APPLICATION of the Applicant filed on 1 August 2018

AND UPON READING:

the Witness Statement of Neville Barry Kahn dated 25 July 2018;

- (3) the written consents of each person who currently holds office with the Applicant, namely Ian Colin Wormleighton dated 13 July 2018; David Philip Soden dated 13 July 2018; Matthew David Smith dated 13 July 2018; Dominic Lee Zoong Wong dated 9 July 2018; Daniel James Mark Smith dated 13 July 2018; Stephen Roland Browne dated 13 July 2018; and Robert James Harding dated 9 July 2018 are also filed herein.

IT IS ORDERED THAT:

1. In relation to the appointments set out in Schedule 1 hereto, Neville Barry Kahn be removed and Nicholas Guy Edwards be appointed as his replacement with the remaining office-holders for each case as detailed in the said Schedule 1 continuing as office-holder in respect of the appointments;
2. In relation to the appointments set out in Schedule 2 hereto, Neville Barry Kahn be removed and Daniel Francis Butters be appointed as his replacement with the remaining office-holder as detailed in the said Schedule 2 continuing as office-holder in respect of the appointments;
3. In relation to the appointments set out in Schedule 3 hereto, Neville Barry Kahn be removed and Philip Stephen Bowers be appointed as his replacement with the remaining office-holders as detailed in the said Schedule 2 continuing as office-holder in respect of the appointments;
4. In relation to the appointments set out in Schedule 4 hereto, Neville Barry Kahn be removed with the remaining office-holder as detailed in the said Schedule 4 continuing as office-holders in respect of the appointments;
5. That the creditors in each case be notified of any order made under this application by advertisement in the London Gazette within 14 days and at the time of the next statutory reporting requirement for each case;
