The organisation is a charitable company limited by guarantee incorporated on the 1 May 2002 and registered as a charity on 9th August 2005. The company was established under a Memorandum of Association which established its objects and powers and is governed under its Articles of Association. Under those articles the Trustees are elected at the Annual General Meeting for a period of three years. New trustees are identified through existing networks or by advertisement and may be invited to attend a board meeting on an exploratory basis prior to cooption, followed by formal election at the following Annual General Meeting. Their induction is managed by the Chair in accordance with their previous experience. The Board welcomes enquiries from people interested in serving as Trustees.

Report of the Trustees of Project Agora for the year ended March 31st 2008

The Trustees present their report and financial statements for the year ended 31 March 2008.

Constitution and Objects

Project Agora, which is also known as Agora, is constituted as a charitable company limited by guarantee whose objects are:

- 1. The promotion of civic responsibility and good citizenship
- 2. The advancement of religion
- 3. The advancement of education

Principal activities to achieve objectives

Agora's experience this year might be aptly summarised in Dickens' phrase 'it was the best of times and it was the worst of times'.

Agora has taken work forward in three areas.

In order to stimulate a wider conversation about climate change we invited a series of well-known speakers to lead evenings in Bristol, including Mark Lynas, Susan Roaf and Leo Hickman. This series was put on in partnership with 'The Climate Outreach and Information Network' and culminated in an event in conjunction with Oxfam that featured George Monbiot, Kate Haworth and others and which attracted around four hundred people.

A series of lunch time conversations provided a new meeting point for local environmentalists, whilst another series called *Holy Ground* took forward our concern to make links with spirituality.

Our continuing interest in working life was expressed through a partnership with St Stephen's Church in Bristol and with Creative Metier. Together we have put in place a series of events for summer and autumn 2008 which focus on working life and spirituality. Agora has also worked with Creative Metier to produce a Christian version of their vocational software and accompanying course, which has been reviewed very positively.

Much of Agora's time and energy this year has been devoted to a green travel initiative called Chooseday. Its aim is to stimulate both conversation and action in regard to climate change. Running with the slogan 'Tuesdays without cars', Chooseday has proved enormously attractive both within Bristol and beyond. It was launched in Bristol in October 2007, gaining support from all the political parties, the council leader, chief executives of the major public sector organisations and business leaders, including Business West. Banners on the hospital and the Council House proclaimed 'Tuesdays without cars' to the city throughout the autumn of 2007.

The Chooseday campaign was founded on a feasibility study funded by 'The Converging World' and it has developed a corporate process that includes the recruiting of Chooseday Champions to take forward the green travel concerns of organisations. A 'Travel and Tell' scheme encourages people to report their alternative travel experiences, while First Bus and First Great Western have provided tickets to new travellers.

The Chooseday campaign achieved national recognition through the Guardian's website, which featured it as Campaign of the Week.



Chooseday has survived through this year on minimal funding with many people giving of their time and energy on a part-voluntary, or at cost, basis. This has made for a dynamic and extraordinarily well-motivated team, but the absence of significant core funding has meant that we have not been able to develop Chooseday as the major city-wide campaign initially envisaged and Chooseday has been a continual threat to Agora's finances.

Agora's Co-ordinator continues to serve on the editorial team of *The Bible in Transmission*, an influential publication among Christian leaders.

Achievements and Performance

In summary the year 2007 – 2008 has been a time when Agora has attained recognition for one of its projects beyond anything we have achieved before, while continuing with a substantial body of other work. At the same time the charity was deeply frustrated in not being able to develop the Chooseday initiative to its full potential due to funding constraints.

Financial review

Our turnover this year has increased markedly, this being largely due to the Chooseday project. Despite increased outgoings we did not have to draw significantly on our reserves over this period.

Having been unable to find a publisher for our 'Bible as Wisdom' series we successfully renegotiated the use of the existing Bible Society grant (£20,000) so as to be able to utilise it for our working life initiative, known as Work and Spirit, and for the development of a new project to be known as Earth Abbey, which will engage the Christian community with environmental issues.

Other major donations included an Awards for All (A4A) grant from Lottery funds towards our climate change speaker series, a grant from Temple Ecclesiastical Charity toward environmental work with churches and a grant from Bristol Archdeaconry Charities toward work with St Stephen's church.

Risk management

The Trustees have examined the major strategic, business and operational risks which the company faces and confirm that systems have been established to enable regular reports to be produced so that the necessary steps can be taken to lessen these risks.

Responsibilities of the Trustees

Company law requires the board of Trustees to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the company as at the balance sheet date and of its incoming resources and application of resources, including income and expenditure, for the financial year. In preparing these financial statements the Trustees should follow best practice and:

- select suitable accounting policies and then apply them consistently;
- make judgements and estimates that are reasonable and prudent; and
- prepare the financial statements on the going concern basis unless it is inappropriate to assume that the company will continue on that basis.



The Board of Trustees is responsible for maintaining proper accounting records which disclose with reasonable accuracy at any time the financial position of the company and to enable them to ensure that the financial statements comply with the Companies Act 1985. The Board are also responsible for safeguarding the assets of the company and hence taking reasonable steps for the prevention and detection of fraud and other irregularities. Having become a charity in August 2005, the Trustees have also prepared this report and accounts in the light of SORP 2005 and its requirements for small charitable companies.

Members of the Board of Trustees

Members of the Board of Trustees who served during the year up to the date of this report are set out on page 3.

Members of the Board guarantee to contribute an amount not exceeding £1 to the assets of the company in the event of winding up. The total number of such guarantees was five as at 31 March 2008.

Independent Examiner

Philip Hodges has been appointed by the board as independent examiner for the year up to 31 March 2008.
