The organisation is a charitable company limited by guarantee incorporated on the 1 May 2002 and registered as a charity on 9th August 2005. The company was established under a Memorandum of Association which established its objects and powers and is governed under its Articles of Association. Under those articles the Trustees are elected at the Annual General Meeting for a period of three years. New trustees are identified through existing networks or by advertisement and may be invited to attend a board meeting on an exploratory basis prior to cooption, followed by formal election at the following Annual General Meeting. Their induction is managed by the Chair in accordance with their previous expenence. The Board welcomes enquiries from people interested in serving as Trustees.

Report of the Trustees of Project Agora for the year ended March 31st 2011

The Trustees present their report and financial statements for the year ended 31 March 2011

Constitution and Objects

Project Agora, which is also known as Agora, is constituted as a charitable company limited by guarantee whose objects are:

- 1 The promotion of civic responsibility and good citizenship
- 2 The advancement of religion
- 3. The advancement of education

Principal activities to achieve objectives

Project Agora has enjoyed a year of unparalleled fruitfulness. Our local currency project, originally pursued in partnership with Transition Bristol, delivered its feasibility study in January 2011 and the project has now formed into its own Community Interest Company known as The Bristol and Bath Local Currency Scheme The currency is currently set to launch in Feb/March 2012

Meanwhile the national growing campaign, known as *Grow Zones*, was brought to the attention of a broad spectrum of people through a dynamic media campaign, which included a strong affirmation by celebrity TV presenter, Alys Fowler Early estimations of the 'on the ground' results of this campaign are mixed, but there is little doubt of its impact in terms of awareness raising. The *Grow Zones* project will end its funding period in February 2012.

In Bristol, Agora's work this year has centred on our own growing project in a tower block estate called Barton Hill. The Church of England have granted Agora a licence to use a substantial former vicarage garden in this multiply-deprived area as a neighbourhood growing project. It is known as *The Walled Garden Project* and works in partnership with several local organisations and other community allotments. The team developing this project have a particular interest in engaging with asylum seekers and refugees and using the garden as a place for community building across social and cultural boundaries around the theme of 'Soil, Soul and Society'. A consortium is currently being formed between Project Agora, Bristol Hospitality Network and the Somali Resource Centre to take the work with refugees and asylum seekers forward. The work has benefited from a number of small grants in this establishment phase and is developing strategic local partnerships with the aim of securing funding in the medium term

The Agora Coordinator has continued his work with Bible Society through the year including the provision of editorial support to the *Transmission* magazine

Our *EarthAbbey* community project has benefited from a revision to its website and simplification of its membership system, through voluntary assistance and the work of a part-time editor.

The multi-faceted nature of our work this year has been achieved through a substantial number of small grants and a team of people larger and more varied than ever before. Our total income this year exceeded all previous years and has resulted in the restoration of our intended reserve position.



The Trustees have examined the major strategic, business and operational risks which the company faces and confirm that systems have been established to enable regular reports to be produced so that the necessary steps can be taken to lessen these risks

Responsibilities of the Trustees

Company law requires the board of Trustees to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the company as at the balance sheet date and of its incoming resources and application of resources, including income and expenditure, for the financial year. In preparing these financial statements the Trustees should follow best practice and

- select suitable accounting policies and then apply them consistently,
- · make judgements and estimates that are reasonable and prudent; and
- prepare the financial statements on the going concern basis unless it is inappropriate to assume that the company will continue on that basis.

The Board of Trustees is responsible for maintaining proper accounting records which disclose with reasonable accuracy at any time the financial position of the company and to enable them to ensure that the financial statements comply with the Companies Act 1985. The Board are also responsible for safeguarding the assets of the company and hence taking reasonable steps for the prevention and detection of fraud and other irregularities. Having become a charity in August 2005, the Trustees have also prepared this report and accounts in the light of SORP 2005 and its requirements for small charitable companies.

Members of the Board of Trustees

Members of the Board of Trustees who served during the year up to the date of this report are set out on page 3.

Members of the Board guarantee to contribute an amount not exceeding £1 to the assets of the company in the event of winding up. The total number of such guarantees was three as at 31 March 2010.
