Structure, governance and management

The organisation is a charitable company limited by guarantee incorporated on the 1 May 2002 and registered as a charity on 9th August 2005. The company was established under a Memorandum of Association which established its objects and powers and is governed under its Articles of Association. Under those articles the Trustees are elected at the Annual General Meeting for a period of three years. New trustees are identified through existing networks or by advertisement and may be invited to attend a board meeting on an exploratory basis prior to cooption, followed by formal election at the following Annual General Meeting. Their induction is managed by the Chair in accordance with their previous experience. The Board welcomes enquiries from people interested in serving as Trustees.

Report of the Trustees of Project Agora for the year ended March 31st 2009

The Trustees present their report and financial statements for the year ended 31 March 2009.

Constitution and Objects

Project Agora, which is also known as Agora, is constituted as a charitable company limited by guarantee whose objects are:

- 1. The promotion of civic responsibility and good citizenship
- 2. The advancement of religion
- 3. The advancement of education

Principal activities to achieve objectives

This year has been a time of endings and beginnings.

Our work at St Stephen's Church in the City Centre attracted attention through several high profile guests including Matthew Taylor, Chris Underhill and Prabhu Guptara. Professor Guptara's address entitled 'The world financial system and the institutionalisation of greed' was providentially timed to coincide with the threatened collapse of the global banking system. Agora's intention to foster conversation on matters of public importance was aptly demonstrated in this event. Unfortunately our 'Work and Spirit' project came to an end earlier than anticipated due to an unexpected failure of trust fund support and our office space at St Stephen's has now been vacated.

In a similar way the *Chooseday* project continued strongly through the early part of the year with notable activities in Bristol Primary Care Trust, Beachcroft LLP and several schools and local communities. We discovered that this 'Tuesdays without cars' campaign worked well when we had active Chooseday champions within the organisation. A project later in the year, on a particularly challenged site of the University of the West of England, was less successful. Funding for *Chooseday* has remained a particular difficulty with continual capacity shortages. A major grant expected from the South West Regional Development Agency (SWRDA) failed to materialize and caused serious damage to our plans for Chooseday's expansion through the South West. Agora is now seeking to pass the Chooseday project on to national travel consultants who have the capacity to take it forward.

Last year's AGM saw the launch of our *EarthAbbey* project, which encourages members to live more in tune with the earth. A fledgling EarthAbbey community has been formed in the Bristol area, together with a project known as *Grow Zones* where people work in teams on each other's gardens to ready them for growing edible produce. This has proved extraordinarily beneficial, not only in the actual growing of food, but also in education about horticulture and land use, the building of community life and a sense of reconnection with the earth. In March 2009 EarthAbbey published a book entitled 'The Dream that inspired the Bible', by Chris Sunderland, the Coordinator of Agora. This development had been facilitated by a grant from Bible Society.

Financial review

The trustees have been considerably exercised about our financial position this year. The termination of the 'Work and Spirit' grant and the failure of expected SWRDA funds came as a hammer blow to our business plans. Sensing the importance of the launch of our EarthAbbey project, the Trustees agreed to allow the spending of a portion of our reserves up to the year end and the Co-ordinator offered to commence part-time working from October 2008.



Risk management

The Trustees have examined the major strategic, business and operational risks which the company faces and confirm that systems have been established to enable regular reports to be produced so that the necessary steps can be taken to lessen these risks.

Responsibilities of the Trustees

Company law requires the board of Trustees to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the company as at the balance sheet date and of its incoming resources and application of resources, including income and expenditure, for the financial year. In preparing these financial statements the Trustees should follow best practice and:

- select suitable accounting policies and then apply them consistently;
- make judgements and estimates that are reasonable and prudent; and
- prepare the financial statements on the going concern basis unless it is inappropriate to assume that the company will continue on that basis.

The Board of Trustees is responsible for maintaining proper accounting records which disclose with reasonable accuracy at any time the financial position of the company and to enable them to ensure that the financial statements comply with the Companies Act 1985. The Board are also responsible for safeguarding the assets of the company and hence taking reasonable steps for the prevention and detection of fraud and other irregularities. Having become a charity in August 2005, the Trustees have also prepared this report and accounts in the light of SORP 2005 and its requirements for small charitable companies.

Members of the Board of Trustees

Members of the Board of Trustees who served during the year up to the date of this report are set out on page 3.

Members of the Board guarantee to contribute an amount not exceeding £1 to the assets of the company in the event of winding up. The total number of such guarantees was four as at 31 March 2009.

Independent Examiner

Philip Hodges has been appointed by the board as independent examiner for the year up to 31 March 2009.
