TRUSTEES' REPORT FOR THE YEAR ENDED 31 MARCH 2007

The trustees present their report and the accounts for the year ended 31 March 2007

Charitable objects

The charity's objects are to promote any charitable purpose for the benefit of the community in Penwith, Kerner and Camck ("the area of benefit") by the advancement of education, the protection and preservation of health and the relief of poverty, sickness and distress

Review of activities and achievements

The Partnership continued to recruit and train CAB volunteers for the benefit of Penwith, Kerner and Carnck Bureaux. Two training courses were completed during the year and two more are planned for 2007-2008. The Court Desk project, managed by Kerner Bureau, for the benefit of Penwith, Kerner and Carnck Districts was continued during the year.

During April 2007 £33,311 was received from Citizens Advice to undertake a feasibility study providing a co-ordinated service incorporating the Gateway model of advice provision

The trustees are actively considering further projects to utilise the balance of funds

Statement of trustees' responsibilities

Company and chanty law requires the trustees to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the chanty and of the surplus or deficit of the chanty for that period. In preparing those financial statements, the trustees are required to

- select suitable accounting policies and then apply them consistently,
- · make judgements and estimates that are reasonable and prudent,
- state whether applicable accounting standards and statements of recommended practice have been followed subject to any departures disclosed and explained in the financial statements, and

The trustees have overall responsibility for ensuring that the chanty has an appropriate system of controls, financial and otherwise. They are also responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the chanty and enable them to ensure that the financial statements comply with the Companies Act 1985. They are also responsible for safeguarding the assets of the chanty and hence for taking reasonable steps for the prevention and detection of fraud and other irregulanties.

1. Accounting policies

1.1 Accounting convention

The financial statements are prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective June 2002) and follow the recommendations in 'Accounting and Reporting by Charities: Statement of Recommended Practice' issued in October 2000
