The company is a wholly owned subsidiary of Pland Group Holdings Limited.

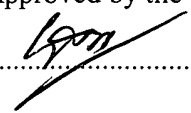
For the period ended 30 November 2016 the company was entitled to exemption from audit under section 480 of the Companies Act 2006 relating to dormant companies.
