

ORDER	

UPON reading the Application dated 28 November 2012

AND UPON hearing the solicitor for the Applicants and reading the evidence

IT IS ORDERED THAT

In respect of those Creditors' Voluntary Liquidations, Compulsory Liquidations, Bankruptcies and Individual Voluntary Arrangement ("the estates") in the Schedule to this Order which are the subject of proceedings in County Courts, those proceedings shall be transferred to

the High Court solely for the purposes of paragraphs 2 and 3 of this order and shall thereafter transferred back to the relevant County Court.

- John Heath be removed from office as Liquidator, Trustee and Supervisor (as the case may be) of the estates listed in the Schedule with immediate effect
- John Heath be replaced by such Office Holder of each such estate by the Applicant named in the Schedule as his proposed replacement with immediate effect.
- John Heath shall be granted his release 56 days after the publication in the London Gazette referred to below

- The Applicants be entitled to publish in the London Gazette one composite notice relating to all new appointments created by this order which are required by law to be published in the London Gazette, such notice to published within 28 days of receipt of the sealed Order, and the Applicants shall file any appropriate notices in respect of the removal of John Heath and the appointment of replacement Office Holders (and those appointments) with the Registrar of Companies and the Secretary of State for Business Innovation and Skills (Insolvency Services) within 14 days of the receipt of the sealed Order
- Notice in writing (which may be by electronic means, if that is possible) of this Order shall also be given to the creditors in each case at the first convenient opportunity to do so without incurring additional expense, such as at the next regular report or notice of meeting (save that the Applicant may incur the expense of notifying creditors if it appears to be necessary to do so in any particular case). For the avoidance of doubt, the replacement office holders shall give notice to creditors of the replacement of Mr Heath at the next creditors' meeting or progress report (as the case may be) as was scheduled prior to the replacement of Mr Heath pursuant to this order, and this provision shall override any reporting requirement in the Insolvency Rules 1986 that would otherwise require a report to be made to creditors on the termination, commencement or replacement of an insolvency office holder's appointment, including those set out at rules 2 47(3A), 4 49B(5), 4 49C-CVL(3) and 6 78A(4).
- The costs of placing notice of this Order in the London Gazette and the costs of this Application be aggregated and be drawn as a proper expense of each of the cases listed in the Schedules which shall each bear an equal proportion of such costs and disbursements where sufficient funds are available (such costs not to exceed £182 60 per estate) and save that an expense borne by a CVA or IVA that would cause it to fail as a result of a breach of its terms shall not be subject to such apportionment
- If in any of the cases listed in the Schedules there are insufficient funds to bear that case's ostensible share of the costs the Applicants may apportion that case's share of the costs

among the other cases listed in the Schedules at his discretion (save that again, the total costs per estate allocated pursuant to this order shall not exceed £182 60 per case)

- 9 Liberty to each creditor of each estate to apply to vary or discharge this order within 28 days of the date of publication of the London Gazette notice directed to be published under paragraph 5 above.
- 10 Liberty to restore
