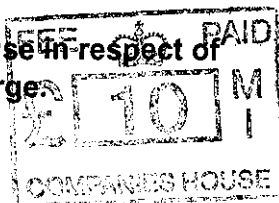

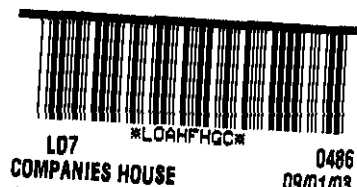



## Notes
