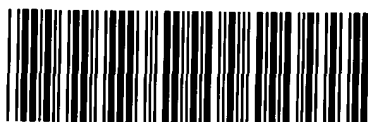

1 Accounting Policy

The Company is incorporated in England and Wales and domiciled in the United Kingdom.
