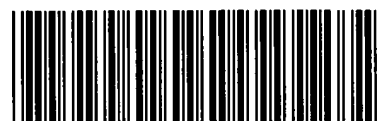



Notes to the Financial Statements for the year ended 31 July 2018

1. ACCOUNTING POLICIES

(a) Accounting Convention

The financial statements have been prepared under the historical cost convention and in accordance with the Financial Standard for Smaller Entities (effective 2015).

(b) Income

The Association of European Competition Law Judges (the Association) was funded by membership subscriptions from courts belonging to the Association and individuals attending the annual conference.

2. EXCHANGE RATE CONVERSION

The majority of the Association's transactions are undertaken in Euros. In preparing these accounts all transactions have been converted using the European Central Bank bilateral exchange rate for 31st July 2018.

The rate used was €1/£ 0.89034.
