Notes to the Statement of Affairs

1 Motor Vehicles

The Company has 3 commercial vehicles which are all subject to outstanding finance with the finance company's detailed in appendix B1 attached. These vehicles were professionally valued by Kayak Asset Valuation Agents Limited ("Kayak"). The estimated to realise value has been based on the agents valuation for a willing buyer basis less the outstanding finance on the vehicles.

2 Furniture and Equipment

The book value has been taken from the Company's records whilst the estimated to realise value is based on Kayaks valuation on a willing buyer basis.

3 Stock and WIP

The Book value has been based on Kayaks assessment of the value of existing contracts. As it is not clear whether these will be completed the estimated to realise value has been shown as uncertain.

4 Cash at Bank

It would appear that payments have been made to the account operated by associated company (AA Windows Limited) represents the proceeds from completed contracts. It is unclear at this time of the quantum of these payments which is currently being reviewed by the associated company's accountant. Therefore, for the purpose of the Statement of Affairs both the book value and estimated to realise values are shown as uncertain.

5 Goodwill

The estimated to realise value has been provided by Kayak and includes the customer database and any intellectual property rights. The valuation is based on a willing buyer basis.

6 H M Revenue & Customs
