NOTES TO THE ABBREVIATED FINANCIAL STATEMENTS

FOR THE PERIOD ENDED 31 DECEMBER 2002

1. ACCOUNTING POLICIES

The following accounting policies have been used consistently in dealing with items which are considered material in the company's financial statements.

(a) Basis of accounting

The financial statements have been prepared under the historical cost convention.

(b) Cashflow statement

The company is a small company. The company has therefore taken advantage of the exemption provided by FRS 1 - Cashflow Statements not to prepare a cashflow statement and associated notes.

(c) Going concern

The company has reported net liabilities at 31 December 2002 of £105,651. The immediate parent undertaking, Sonda Properties, Inc has undertaken not to demand repayment of its loan to the company such to render the company unable to meet other liabilities as they fall due. Accordingly the directors consider that the going concern basis is an appropriate basis for the preparation of these accounts.

(d) Turnover

Turnover represents the amounts invoiced to customers and is stated exclusive of value added tax.

(e) Investments

Investments are stated at cost, including the cost of associated expenses, less any provisions for permanent diminution in value.

(f) Deferred taxation

Provision is made for taxation deferred as a result of material timing differences between the incidence of income and expenditure for taxation and accounts purposes, using the liability method, only to the extent that, in the opinion of the directors there is a reasonable probability that a liability or asset will crystallise in the near future.

(g) Foreign currencies

Transactions in foreign currencies are translated at the exchange rate ruling at the date of the transaction. Monetary assets and liabilities in foreign currencies are translated at the rates of exchange ruling at the balance sheet date.
