The declaration of solvency, sworn by the directors prior to the commencement of the liquidation showed a debt due from Six Continents Limited ('SCL'), another group company

The Company had no known creditors. A notice to creditors to prove their claims in the liquidation was advertised in The London Gazette on 7 April 2015. No creditors were forthcoming as a result of this advertisement.

Tax

All pre-liquidation corporation tax matters were handled by the company's tax advisors who prepared and submitted all outstanding returns up to the date of the liquidation to HM Revenue & Customs ('HMRC'). HMRC subsequently confirmed that the Company had no outstanding corporation tax returns or liabilities, that it would not raise enquiries into any pre or post liquidation periods and that it had no objection to the liquidators calling a final meeting of members to conclude the liquidation.

A similar assurance was sought and received from HMRC in respect of PAYE.

The Company was not registered for VAT.

Distributions

There were no distributions during the period.

Joint Liquidators' remuneration and expenses

A written resolution was passed on 23 March 2015 that the remuneration of the Joint Liquidators be fixed at their normal charging rates according to the time properly spent by them and members of their staff in attending to matters arising in the winding up of the Company.

In the event, the Joint Liquidators' remuneration has been paid by another group company and accordingly no detailed analysis is included in this report.

Final Meeting

The final meeting to conclude the liquidation has been convened for 20 June 2016
