**UPON** reading the application of Martin Charles Armstrong, Andrew Richard Bailey dated 10 January 2020 (the **Application**)

AND UPON reading the Witness Statement of Martin Charles Armstrong dated 10 January 2020

## IT IS ORDERED THAT:

Under Chapter 6 (Sub-division B) of Part 12 of the Insolvency (England and Wales) Rules 2016 (SI 2016/1024) (the Rules) that

The creditors' voluntary liquidations (CVLs), compulsory liquidations (WUPs), members' voluntary liquidations (MVLs), individual voluntary arrangements (IVAs), company voluntary



arrangements (CVAs), administrations and bankruptcies listed in Schedules 1 to 7 (the Appointments Schedules) of this Order, which are the subject of proceedings in County Courts, or Hearing Centres, in England and Wales, be transferred to the High Court of Justice, Business and Property Courts of England and Wales, Insolvency and Companies List, solely for the purpose of making the Order contained in paragraphs 2 to 17 below.

- Immediately upon this Order taking effect, the cases listed in the Appointments Schedules be transferred back to the relevant County Court or Hearing Centre.
- That Lynn Gibson of 5 Park Court, Pyrford Road, West Byfleet, Surrey, KT17 6SD (the **Outgoing Office Holder**) be removed from office as liquidator (voluntary or compulsory), administrator, trustee in bankruptcy or supervisor (as the case may be) of the estates listed in the Appointments Schedules, from the date of this Order.
- That Martin Charles Armstrong and Andrew Richard Bailey of Turpin Barker Armstrong (**TBA**) be appointed as replacement joint office holders (**Replacement Joint Office Holders**) of the estates listed in the Appointments Schedules, from the date of this Order.
- The appointments of the Replacement Joint Office Holders referred to in this Order are joint appointments and the functions of the Replacement Joint Office Holders may be exercised by any or all of the persons appointed.
- The Outgoing Office Holder shall be released from all liability pursuant to the relevant sections of the Insolvency Act 1986 (IA86) in respect of her acts and omissions and otherwise in respect of her conduct in relation to each of the estates in the Appointment Schedules, without being required to (i) apply to the Secretary of State for release or discharge as appropriate pursuant to s173(2)(b) and s174(4)(b) of IA86 as the case may be or (ii) file a receipts and payments account, such release to take effect in relation to each relevant estate 56 days after the date that the notices referred to in paragraph 7 of this Order are published. Save that, such order may be subject to further order of the Court in the event of an application by any creditor or member under paragraph 11 of this Order in relation to a specific estate, subject to that application.
- The Replacement Joint Office Holders shall give notice of this Order to creditors of those estates listed in Schedules 1, 3, 4, 5, 6, and 7 which are listed as being in CVL, WUP, Administration, Bankruptcy, IVA or CVA and to members of those estates listed in Schedule 2 as being in MVL, by publishing one composite notice relating to the resignation and appointments as detailed in the Appointments Schedules in the London Gazette and must do so within 14 days of receipt of the sealed Order.
- Permission is given to the Secretary of State to apply to vary this Order at any time up to 28 days after the notices referred to in paragraph 7 above are published.

- 9 The Replacement Joint Office Holders shall notify the Secretary of State and the Registrar of Companies as soon as reasonably practicable following the making of this Order.
- Service of the said Application and this Order on each of the companies and individuals listed in the Appointments Schedules attached to this Order be dispensed with.
- The Replacement Joint Office Holders shall file a copy of this Order with each of the County Courts listed in the Appointments Schedules.
- There shall be liberty to each creditor of those estates listed in Schedules 1, 3, 4, 5, 6, and 7 as being in CVL, WUP, Administration, Bankruptcy, IVA or CVA and to each member of those estates listed in Schedule 2 as being in MVL, to apply to vary or discharge this Order insofar as it relates to the estate of which they are a member (in the case of MVL) or a creditor, as the case may be, within 56 days of the member or creditor (as the case may be) being given notice of this Order pursuant to paragraph 7. Such applications shall not affect the transfer of the block transfer cases listed in the Appointments Schedules until Ordered by the court.
- The costs of this Application (including VAT) shall be paid by TBA, without recourse, directly or indirectly to the estates listed in the Appointments Schedules of this Order.
- Subject to paragraph 13 above, in the event that, as a result of the implementation of the Order TBA incurs any additional cost in respect of the administration of those estates (that is to say over and above those costs incurred in the ordinary course of the administration of those estates), those costs shall be borne by TBA and shall not be charged as an expense of the administration of those estates.
- Nothing contained in paragraphs 13 or 14 shall prejudice the applicants or the respondents from:
- 15.1 Charging to each individual estate the cost of obtaining an Insolvency Practitioner's licence bond in respect of that estate; and
- 15.2 Apportioning between the said estates equally the cost of the composite Gazette notice to be placed under paragraph 7 above.
- Without incurring any additional expense for any of the said estates, the Replacement Joint Office Holders shall notify each creditor of this application and this Order by way of notice in the next routine report (and the dates for the next routine report as they applied immediately prior to this Order shall continue to apply) that shall be due to the creditors of each estate, such notice to contain the following matters:
- 16.1 an explanation of the effect of this Order;
- 16.2 express reference to the liberty to apply contained in paragraph 12;

in the case of Liquidations, where Liquidation Committees or Creditors' Committees have been appointed, an explanation that, to the extent that any information which would otherwise be required to be provided under Rule 6.25(5) or Rule 7.61(5) (as the case may be) of the Rules

has not already been provided as part of the report, it is open to that committee to require the

Applicants to provide an account of the administration of the estate, including a summary of

receipts and payments, and a statement that they have reconciled the accounts;

16.4 in the case of Liquidations where no Liquidation Committees or Creditors' Committees have

been appointed, an explanation that, to the extent that such information as aforesaid has not

already been provided as part of the report, it is open to any creditor to apply to court for an Order that the Applicants do provide an account of the administration of the estate, including a

summary of receipts and payments, and a statement that they have reconciled the accounts;

16.5 notification that if the Replacement Joint Office Holders have been required to provide the

information referred to in sub-paragraphs 16.3 and 16.4 above, whether by a Liquidation

Committee or by court order on the application of any creditor(s), the costs of the Replacement

Joint Office Holders of so complying will, unless there are good reasons to the contrary, be paid

as an expense of the winding up, administration or bankruptcy as the case may be; and

16.6 in the case of Liquidations, notification to each creditor of his right under regulation 11(2) of the

Insolvency Regulations 1994 to require the Replacement Joint Office Holders to supply a

statement of receipts and payments free of charge.

17 The Replacement Joint Office Holders have the right to apply to the court to amend this Order

to include any appointments held by the Respondent which have been inadvertently omitted

from the Application.

## Notice of Replacement Insolvency Practitioner as per the attached Court Order CR-2020-000172

Staff from the liquidation team of Companies House have advised us that for CVAs there is no standard form to send to the Registrar to notify where there is a change of IP acting as Supervisor. Accordingly, we have been advised to notify you of these changes by letter.

On 14 January 2020, an order in the High Court of Justice under the reference, ("the Order"), effected a block transfer of cases from Lynn Gibson of Gibson Hewitt to Martin Charles Armstrong and Andrew Richard Bailey of Turpin Barker Armstrong, 5 Park Court, Pyrford Road, West Byfleet, Surrey KT14 6SD. Accordingly, Martin Charles Armstrong and Andrew Richard Bailey are now the Joint Office Holders in respect of this insolvency appointment and are hereafter referred to as "The Replacement Joint Office Holders". The Replacement Joint Office Holders are authorised to act either jointly or separately by the Order. Furthermore, under the Order Lynn Gibson of 5 Park Court, Pyrford Road, West Byfleet, Surrey KT14 6SD was removed from office as the Office Holder in respect of this insolvency appointment with effect from 14 January 2020.

As required under the Order, the Replacement Joint Office Holders are required to bring the following to your attention:

- There shall be liberty to each creditor of the insolvency estate, (or member in respect of an MVL), to apply to vary or discharge the Order insofar as it relates the estate of which they are a member or creditor, as the case may be, within 56 days of them being given notice of the Order by way of advertisement in the London Gazette. Such applications shall not affect the transfer of the block transfer cases until Ordered by the court.
- In the case of Liquidations where no Liquidation Committees or Creditors' Committees have been appointed; to the extent that such information as aforesaid has not already





been provided as part of the report, it is open to any creditor to apply to court for an Order that the Replacement Joint Office Holders do provide an account of the administration of the estate, including a summary receipts and payments, and a statement that they have reconciled the accounts.

- If the replacement Joint Office Holders have been required to provide the information referred to in the above paragraph, whether by way of liquidation committee or by court order on the application of any creditor(s), the costs of the Replacement Joint Office Holders of so complying will, unless there are good reasons to the contrary, be paid as an expense of the winding up, administration or bankruptcy as the case may be.
- In the case of Liquidations, each creditor is hereby notified of his right under regulation 11(2) of the Insolvency Regulations 1994 to require the Replacement Joint Office Holders to supply a statement of receipts and payments free of charge.


